Sharma said that they have begun preparations for holding Panchayat polls in Jammu & Kashmir. "We have to be ready for the polls and we are making preparations in this regard," he said.

Sharma said the poll process has to be completed one month before completion of the term of existing Panchayats.

The five -year term of Panchayats would end on January 9, 2024 as they were constituted on January 10, 2019. The last Panchayat

polls in Jammu & Kashmir were held in November-December 2018 when the erstwhile state was under

November 2023 if Centre and Jammu & Kashmir Government decides to conduct them.

The term of Block Development Councils in Jammu & Kashmir would also end on January 9 next year as they are co-terminus with Panchavats.

The meeting focused on the urgent need for document updation by residents who have not updated their Aadhaar details in the last 10 years. In this context, the Unique Identification Authority of India (UIDAI) has disseminated pamphlets and posters across all blocks of Jammu and Kashmir to raise awareness regarding document updates.

An action plan was devised during the meeting to address the challenges and expedite the Aadhaar registration process which includes preparation of School-wise and class-wise lists of children requiring Mandatory Biometric Updates (MBUs); roster for the movement of MBU kits in the schools. besides roping in Health and ICDS for the enrollment of children in the age group of 0-5 years.

Dr Mehta called upon Deputy Director General UIDAI, Regional Office Chandigarh, that awareness campaigns be conducted by the School Education Department at all locations, besides efforts to increase the turnout in schools.

Regarding the availability of functional Aadhaar centers, it was reported that 780 permanent centers and 450 mobile tablets are operational throughout the UT. The Chief Secretary urged for activation of all these centres and optimum utilization of their resources in order to bridge the gap between the actual population and registrations made so far.

In an effort to cover all school students under Aadhaar registration, Dr Mehta directed concerned officers to ensure that 100 percent of students in schools, including those not yet registered under Aadhaar, are included within the next six months. He also emphasized on the importance of registering for Aadhaar during births, whether in government-run or private hospitals in order to saturate it on real time basis

Furthermore, the Chief Secretary urged all officers involved to raise awareness about the Aadhaar updation process by ensuring 100 percent functionality of all Aadhaar centers.

The meeting also highlighted the approval of proposals under the Aadhaar Authentication for Good Governance (Social Welfare, Innovation, Knowledge) Rules, 2020. Some of the approved proposals include the eKYC registration of Yatris by Shri Amarnath ji Shrine Board at all counters across J&K, authentication of applicants for property-related documents by the Department of Registration, DBT linked beneficiary oriented schemes and authentication of applicants for Domicile Certificates by the Revenue Department.

Dr Mehta reaffirmed that with the comprehensive plan in place and the and arms being adopted by Pakistan were discussed," police said.

Ganderbal's Shiv Temple All Set For Pilgrim Tourism

GANDERBAL: Nestled in the breathtaking landscapes of central Kashmir's Ganderbal district lies an ancient Shiv Temple. This holv site is located in Manasbal, on the front side of the Wullar Manasbal Development Authority (WMDA) office.

Abdul Rasheed, a local caretaker employed as a casual laborer at the WMDA, said that the temple had submerged in the tranquil waters of the pond but today, it stands revitalized, making it a new pilgrimage attraction.

"The temple had been partially submerged, with half of its magnificent structure gracefully resting under the water's surface: however.

when the Wular Manasbal Development Authority was formed, they recognized the temple's significance and embarked on an ambitious renovation project, breathing a new life into the edifice." he said.

The Shiv Temple is a remarkable example of Kashmir's architectural brilliance, constructed using enchanting grey stones

Over the years, it has witnessed the passage of time, preserving the essence of centuries gone by. The temple is believed to be built during the 9th century CE by King Avantivarman, the founder of the Utpala dynasty.

"Legends say that it once stood tall as a submerged stone temple, embracing



the mystique of time," said casual laborer working in the Ghulam Rasool, another area

Adding to the allure of the site, the pond's water is said to be remarkably sweet and healthful. Visitors are drawn not only to the temple's ancient charm but also to partake in the purity of the water, a rarity in today's bustling world.

tives for the welfare of the women include Pradhan Mantri Surakshit Matritva Abhivan (PMSMA) and Pradhan Mantri Matru Vandana Yojana (PMMVY), Mandaviya said. The PMSMA provides preg-

nant women a fixed day, free of cost assured and quality antenatal check up by a specialist/medical officer on the ninth day of every month, he said. The PMMVY is a maternity

benefit program run by the Minis-



try of Women and Child Development. The scheme aims to cover women belonging to socially, economically disadvantaged and marginalised sections of society," Mandaviya said.

All pregnant women who have their pregnancy for the first child in family on or after January 1,2017, are eligible for getting benefit under the programme, he said. Among the schemes and initiatives for malnourished children

include Mothers Absolute Affection (MAA), to improve breastfeeding coverage and appropriate breastfeeding practices in the country, and Anaemia Mukt Bharat (AMB) strategy to reduce prevalence of anaemia in children (6-59 months), children (5-9 years), adolescent girls and boys (10-19 years), pregnant and lactating women and in women of reproductive age group (15-49 years), Mandaviya added

The Dead Drops Of Online Terrorism

y fundamentalism, a person or group adopts increasingly radical views in opposition to the political, social, or religious status quo. This is when someone begins to believe in or support extremist ideas and then participates in extremist groups or acts. Online platforms have become powerful tools for extremist groups to spread their ideology, recruit individuals, and plan terrorist acts. Therefore, intelligence and counter-terrorist agencies must keep pace with the ever-changing digital landscape and adapt their functioning accordingly. This requires regular evaluation of their existing strate-gies to identify deficiencies and areas for improvement.

Recently, India witnessed a series of extremist acts by some radicalized youth in various cities such as Udaipur, which later escalated to "Sar tan se juda" sloganeering and related controversy. Last year too, the NIA made several arrests in a suspected ISI module that was playing a role in radicalizing Indian youth and carrying out extremist acts in India. The above incidents highlight the issue of radicalization of Indian youth which can pose a serious challenge to India's internal security. NIA has intercepted information about recruitment propaganda for terrorist groups like AQIS, and Lashkar-e-Taiba on Telegram. Daesh is using the internet to spread its propaganda using platforms like Twitter, YouTube, etc. Through 'cyber-planners', who would be

responsible for planning terror attacks, identifying recruiters, acting as "virtual coaches" and providing guidance and encouragement throughout the process

India has also suffered in recruitment from other countries, though less severely. In many areas, the cases of propagating hatred and violence by influencing the youth through social media are increasing. Spreading false propaganda and fraudulent ideologies on India's sensitive and provocative issues, using morphed videos or false claims of proof of injustice, etc. Manipulation is easy on the internet and more youths are falling prey to it, especially in the northeast, Kashmir. The NIA had reported the recruitment of over 300 Indian youths by the Pakistan-based Tehreek-e-Taliban (TTP) in 2014, who had joined hands with ISIS. ISIS has published recruitment materials in Hindi, Urdu, Tamil, and other languages are spoken in India.

To promote research in the area of radicalization relating to different

regions of India for a deeper understanding of the issue and to develop better solutions. Ensuring adequate funding for these programs, capacity building of intelligence forces, and creation of modern infrastructure to combat radicalization, especially virtual radicalization. Capacity building of the State Police as they are the first line of defense. State police forces need to work in good coordination with central security agencies to better counter the growing radicalization. Coverage of various welfare schemes of the government without discrimination, special schemes and areas for communities, promotion of mixed culture and coexistence among different communities, and constitutional safeguards for minorities are some of the steps that the government is taking to keep people away from radicalization. Launching a de-radicalization program that focuses on states with high intensity of radicalization and also developing counseling and rehabilitation centers for radicalized youth under police custody.

Increase involvement of family and religious leaders not only in the process of rehabilitating radicalized youth but also in preventing youth from moving towards radical ideologies. To prevent people from falling into the trap of extremists, to raise awareness in societv about these threats through school and college education or social media accounts of security agencies. A coordinated South Asian effort to counter radicalization can also be of great help to the region as all countries in the region are facing the heat of radicalization.

The ever-evolving landscape of online recruitment and radicalization requires intelligence and counter-terrorism agencies to be flexible, adaptive, and proactive. By constantly reviewing their strategies, leveraging emerging technologies, and staying informed about the latest trends, these agencies can effectively reduce the threat posed by online radicalization in India.



lives of every person worldwide, we will fail to deliver on those promises. Local actions are key. That is why the Mayors of several municipalities in Bangladesh and other local government leaders and experts had united to form the Bangladesh Mayors' Alliance for Healthy Cities in 2019.

"Well-coordinated actions at the local level are building blocks to deliver on global goals. If all local governments of all municipalities in Bangladesh work towards reducing (and eventually ending) tobacco use and TB, and preventing non-communicable diseases (NCDs), we will be able to deliver on the promises made by Bangladesh's honourable Prime Minister," said Barrister Shameem Haider Patwary, Member of Parliament of Bangladesh and co-convener of Asia Pacific Parliamentarians Caucus for Health and Development (APCAT Parliamentarians).

Barrister Patwary was addressing the 3rd Mayors' Summit of Bangladesh held in Cox's Bazar during 21-22 July 2023 om the theme "United efforts for healthy cities." The Summit was co-hosted by the Cox's Bazar Municipality, National Tobac-co Control Cell (NTCC), Ministry of Health and Family Welfare of Bangladesh, Bangladesh Mayor Alliance for Healthy Cities, International Union Against Tuberculosis and Lung Disease (The Union), Asia Pacific Cities Alliance for Health and Development (APCAT), AID Foundation, Tobacco Control and Research Cell (TCRC) of Bangladesh and others.

One Health approach is key to boost pandemic preparedness

"United efforts at all levels are vital if we are to end TB, or tobacco use, or prevent NCDs. Major risk factors of life-threatening and chronic NCDs (over 70% of deaths are attributed to NCDs worldwide) and TB (the deadliest of infectious diseases in most low- and middle-income nations) are common: such as tobacco, alcohol, malnutrition, obesity, lack of physi-



cal activity, etc. That is why, united, and well-coordinated efforts at the local level assume an overwhelming importance so that local people can stay healthy, prevent infections, and reduce the risk of NCDs," said Dr Tara Singh Bam, Asia Pacific Director of International Union Against TB and Lung Disease (The Union).

"Mayors play a critical role in tobacco control by implementing and enforcing policies, raising public awareness, and creating smoke-free environments in their cities to protect the health of their citizens" added Dr Bam.

"Mayors' role is also critical to address and prevent any pandemic through One Health approach," emphasized Dr Tara Singh Bam.

According to the latest WHO Global TB Report, undernourishment was the biggest risk factor for people getting sick with TB in Bangladesh in 2021, followed by tobacco use as the second biggest risk factor. Other risk factors included diabetes, alcohol and HIV.

Bangladesh aims to be tobaccofree by 2040

Bangladesh's Prime Minister has promised to make the country

tobacco-free by 2040, said SM Sirajul Haque, Mayor of Tangail in Bangladesh. He said that we cannot create a smart Bangladesh unless children and adults alike make smart decisions which are good for them and for the country. If people use tobacco then they will be unhealthy and also cause havoc on their family. Staying away from tobacco use is vital. That is why he is encouraging those who use tobacco in his Tangail region to quit tobacco use by benefitting from tobacco cessation services. Tobacco retail is not allowed within 100 metres of educational institutions and to those who are under 18 years of age, he added.

Tobacco use in Bangladesh has reduced in the past 20 years as per the World Health Organization (WHO) Global Health Data Observatory. From 57.6% in 2000, tobacco use has come down to 34.7% in 2020. However, tobacco consumption in Cox's Bazar was found to be higher than the national average at 43.4%.

Tobacco use is a major public health challenge in Bangladesh, with high rates of both smoking and smokeless tobacco use. Smokeless tobacco use is particularly prevalent in Bangladesh, with over 20 million people using various forms of smokeless tobacco, like jarda and gul . Tobacco consumption in Bangladesh has significant health consequences, as it is a leading cause of NCDs such as cancers, cardiovascular diseases (heart diseases and stroke), and chronic respiratory diseases. Additionally, tobacco use has significant economic costs, both in terms of direct healthcare costs and lost productivity.

Bangladesh is the 3rd biggest tobacco growing country in the southeast Asia region of the WHO (after India and Indonesia). Land under tobacco cultivation had seen a substantial rise in Bangladesh during 2008 and 2015, but now dedicated efforts of the Bangladesh government have led to success in farmers choosing not to grow tobacco, but rather opt for cultivating other crops. Bangladesh has ratified the global tobacco treaty (formally called the WHO Framework Convention on Tobacco Control or FCTC), Article 17 of which calls upon governments to promote economically viable alternatives for tobacco workers, growers and individual sellers.

According to the WHO, farmers in India, Sri Lanka, Bangladesh, and Indonesia are gradually taking to Tobacco Cultivation Control Policy of Bangladesh, 2017, has set targets to reduce tobacco cultivation at all stages by 2040. In early 2020, Bangladesh Bank notified all its branches not to sanction loans for tobacco farming-both contractual or direct. It is also increasing credit flow to farmers switching to alternative crops.

Several surveys have already identified alternative crops for different cropping seasons and for different geographical areas. Alternatives include French beans, potato, melon, sweet gourd, chilli, eggplant, groundnut, tomato, wheat, garlic, masur, mustard and leafy amaranthus, radish, coriander, okra, bitter gourd, beans, spinach and cabbage.

A report stated that farmers in water-scarce northern Bangladesh are shifting away from tobacco to grow tea, sunflower and mustard, which use less water and offer greater profits.

Strengthening leadership commitment

This Mayor's Summit aimed to enhance mayors' leadership role by prioritizing prevention of tobacco use, TB and NCDs, within the framework of strategic and operational planning, as well as in policy, fiscal, and legislative instruments. There need to be strong mechanisms to ensure that mayors and leaders at local level are held accountable for safeguarding the development and implementation of public health policies from undue influence of unhealthy commodity industries. This will involve promoting transparency, enforcing strict guidelines, and cultivating strong public-private partnerships to effectively implement programmes, while also monitoring their performance and effectiveness

10 years on, Chanapora residents await upgradation of PHC to SDH



Demand will be taken up with higher-ups: DHSK JAHANGEER GANAIE

SRINAGAR: Even after an elapse of around ten years since foundation stone of the hospital was laid in housing colony Chanapora Srinagar, the residents have been waiting for up-gradation from PHC to sub- district hospital.

Locals said that for the last ten years they have moved from pillar to post to make this PHC function as a SDH but that didn't happen despite an amount of over Rs 20 crore spent on the building.

They said that this hospital, situated in the heart of the city, has been causing distress among local residents due to its restricted operating hours and dysfunctional Operation Theatres (OTS).

Despite substantial financial investments amounting to crores of rupees, the hospital is yet to be upgraded to a fully functional healthcare facility, leaving the community in dismay, they said.

The hospital, which currently operates from 10 a.m. to 4 p.m. daily, has faced criticism from residents who argue that the limited working hours are inadequate to cater to the medical needs of the growing population in the area.

"I had to rush my elderly mother to Chanapora Hospital during an emergency last week, but to my shock, the hospital was closed as it was past 4 p.m.," said Rakesh Sharma, a local resident was quoted as saying by news agency KNO.

"We had to travel to a different part of the city to get the necessary medical attention. It's disheartening to see a hospital in the city functioning with such restricted hours,

It is a 50-bedded hospital but it is of no use and it remains functional much like a government office," he said.

Another resident, Farida Bano, narrated her harrowing experience, saying, "Doctor consulted me for an X-Ray but when we asked them to do so, we were told that it can't be done despite X-Ray machines as the hospital lacks manpower. This is an unacceptable situation for a hospital that received significant funds for its development."

Despite promises from the authorities to upgrade the hospital into a fully functional and well-equipped healthcare facility, progress has been slow, leaving locals disillusioned with the state of their primary medical center.

It is pertinent to mention here that during the Covid-19, hundreds of surgeries were carried out at the hospital. However, as soon as the Covid-19 pandemic came to end, surgeries were halted at the hospital giving a tough time to patients.

Concerned Counselor and community leaders have voiced their concerns and are demanding immediate action from the government.

"The lack of proper medical facilities in our area is a matter of grave concern," said J.B. Singh, a community leader.

"We have been waiting for years for Chanapora Hospital to be upgraded, but nothing substantial has been done. It's high time the authorities take this matter seriously and address the issue on an urgent basis."

As the situation continues to deteriorate, the plight of Chanapora Hospital highlights the urgent need for increased investment in healthcare infrastructure and the timely execution of promised upgrades.

The local residents hope that their voices will be heard, and the hospital will soon be transformed into a fully operational facility that can cater to the medical needs of the community around the clock.

Meanwhile, the spokesperson of Directorate of Health Services Kashmir, Dr Mir Mushtaq said that the demand will be taken with higher-ups at an earliest.

"The concerns and demands of people will be taken up with higher authorities in due course of time," the spokesperson said.

China getting isolated in international arena; faces slumo in external trade

CHINA: There are growing signs of China getting isolated in the international arena economically. This is standing in the way of the Chinese economy recovering from the slump it had experienced during the pandemic. According to an AP report from Beijing on June 7. 2023, exports of China in May 2023 fell by 7.5 percent compared to the figure in May 2023 and imports were down by 4.5 percent; a sure sign that the economic rebound following the end of the anti-virus control is slowing as the global demand for Chinese goods is weakening.

Exports slid to \$283.5 billion, reversing the unexpectedly strong 8.5 percent growth experienced in April 2023. Imports fell by \$217.7 billion, on the top of the 7.9 percent contraction experienced in April. The global trade surplus of China fell by 16.1 percent to \$65.8 billion in May 2023. Between January and May 2023, imports of China fell by 6.7 percent compared to the same five-month period in 2022 to just over \$1 trillion while export growth fell close to zero. Exports slid up merely 0.3 percent to \$1.4 trillion.

The situation was worse in June 2023, said an AP report from Hong Kong on July 13. The exports of China tumbled by 12.4 percent compared to what they were in June 2022. Imports slid by 6.8 percent. Between January and June, 2023, the total trade of China, including exports and imports, fell nearly five percent from the figure in the comparable period in 2022. Exports slipped by 3.2 percent and imports by 6.7 percent.

The growth rate in the gross domestic product of China in

the quarter from April to June 2023 at 6.3 percent was lower than the projected rate of seven percent. It outpaced the growth rate of 4.5 percent in the quarter from January to March 2023 but is expected to slow down in the next quarter because of the fall in exports by 12.4 percent. Among the Western Bloc countries, exports of China to the United States have tumbled 18.2 percent to \$42.5 billion compared to the figure a year earlier.

Imports of American goods have sunk 9.9 percent to \$14.3 billion. The much-vaunted trade surplus of China with the United States has narrowed by nearly 22 percent to \$28 billion. With the European Union, the picture is similarly dismal. In May 2023, the imports of China from the 27-nation EU fell by 38.6 percent to \$24.5 billion compared to the same period the previous year. Exports to Europe fell by 26.6 percent to \$44.6 billion. The trade surplus of China with the EU fell by three percent to \$20 billion.

Trade has been dampened by tensions with Washington and restrictions on access to U.S. processor chips and other technology in the ongoing cold war with Beijing over security and Chinese industrial policy. The falling imports were also indicative of faltering demand within China because of the economic crisis it is facing. As far as hi-tech products are concerned. Chinese factories are mere assembly lines, assembling most of the world's smartphones and other electronic items. Now with the Western world denying advanced tech-

lines are lying idle.



the semiconductor industry in the world, has meanwhile decided to close its manufacturing facilities in China and shift them to India. Weakness in trade has added to the downward pressure on the economy of China. This has been coupled with lackluster factory and consumer activities and a surge in unemployment among young people.

A brief bounce-back had been experienced immediately after the withdrawal of restrictions related to the pandemic. Factory output and consumer spending had revived after the control that had cut off access to major cities for weeks at a time and blocked most international travel was lifted in December 2022.

Forecasters are saying the peak of that rebound has passed. Retail spending is recovering more slowly than nology to China, these assembly expected because jittery consumers are worried about the Taiwan, which is the leader in economic outlook and possible

job losses. A government survey in April 2023 found a record of one in every five young workers in the cities was unemployed. Factory activity is contracting and employers are cutting jobs. "China's exports will remain subdued," Lloyd Chan of Oxford Economics has said in a report.

The "disappointing activity data" of April suggests "China's domestic demand recovery has lost steam following the reopening-induced bounce."The growth target set by the ruling Communist Party of China of five percent for the year 2023 in any case sounds like a distant dream. There is bad news for China on the India front also.

The India – China trade which in recent years had risen sharply despite bilateral tensions over the border dispute, has shown the first signs of a slowdown in years; falling by nearly one percent in the first half of 2023. China's exports to India in the first half of 2023

totaled \$56.5 billion, compared to \$57.5 billion in the same period last year, according to reports from Beijing on July 13, quoting data released by Chinese customs.

India's exports to China during the same period were \$9.5 billion, compared to almost the same figure in the comparable period last year. The trade deficit of India with China in the first half of 2023 declined significantly to \$47 billion, compared to \$67 billion in the same period in 2022. Exports to the Association of Southeast Asian Nations, which is the largest regional trading partner of China and one that has hitherto provided major support to the export sector of the Chinese economy, fell by nearly 17 percent in the first half of 2023 compared to the comparable period in 2022.

Ironically, while releasing figures, Chinese General Administration of Customs

spokesman Lu Daliang sounded pessimistic. He said on July 13 China would be facing more pressure to ensure stable growth in foreign trade in the latter half of the year. For this, he largely blamed the "geopolitical conflicts." Now with the larger world shunning trade relations with China, Beijing will have to depend on domestic demand, experts say.

The trends show that this is unlikely. It will be difficult for domestic demand to rebound without much stimulus from the government. Faced with a situation where most of the world is refusing to humor Beijing with stepped-up trading relations, China is falling back on Russia for external trading. Imports from Russia, mostly oil and gas, have risen by 10 percent over a year, to \$11.3 billion. Exports to Russia have surged by 114 percent to \$9.3 billion.

China is buying more Russian energy to take advantage of price cuts, helping to shore up the Kremlin's cash flow after the United States, Europe, and Japan have cut off most purchases to punish Moscow for President Vladimir Putin's invasion of Ukraine. Beijing can buy Russian oil and gas without triggering Western sanctions. China has now become Russia's biggest export market and an important source of manufactured goods.

To make up for the loss of export markets to the USA and the European Union. China is trying to step up trade relations with the ASEAN countries. The hype over growing relations between China and the ASEAN countries notwithstanding. there too exports have fallen. In any case, the ASEAN countries will not be able to make up for

the loss of the American market for the Chinese economy, says Bruce Pang, chief economist at JLL, a global investment management company.

In the American market, companies can sell at a higher profit margin. Experts have noted that among the 10-member ASEAN group of countries, including Indonesia, Malaysia, Thailand the Philippines, Singapore, Brunei, Myanmar, Cambodia, Laos, and Vietnam, there is plenty of distrust of Chinese policies and motivations.

The maritime claims of China are antagonizing many countries in this region. The threat of Chinese debts weighs heavily on many of the states. China is evidently facing the pinch of the cold shoulder from the Western countries, analysts say; hence the cold shoulder to the visit by U.S. Treasury Secretary Janet Yellen to China in the first week of July 2023. when Beijing sent a flotilla to the Taiwan Strait

According to the BBC, the key factor was the export controls imposed by Washington on some microchips. That is standing in the way of China developing its own Artificial Intelligence. The visit of the U. S. Treasury Secretary met with limited success, at best.

On July 14, 2023, China criticized a call by the German government for reducing dependency on Chinese products and decreasing other potentially unstable factors in bilateral relations as "protectionism." Foreign Ministry spokesman of China Wang Wenbin said the strategy of relations with China announced by Berlin pointed to a "systematic rivalry" and would aggravate divisions in the world. 22 countries opened special bank accounts Building Future of Children in Rural in India to trade in Rupee: Minister

Stating India as one of the fastest-growing countries which showed remarkable resilience even in the face of major headwinds, the IDG said it feels that the rupee has the potential to become an internationalised currency. Pakistan: Heavy rains cause urban flooding in Sindh

SINDH: Heavy rains on Sunday hit Pakistan's Hyderabad, Mirpurkhas and Dadu districts of Sindh province, causing urban flooding in the wake of the breakdown of the drainage system and suspending power supply, Dawn reported.

It started raining heavily in Pakistan's Hyderabad on Saturday night and continued into Sunday till 2 am when it rained around 45 minutes. The power supply went off with the first drop of rain causing a massive breakdown early on Sunday.

At around 4:30 pm, the second spell of rain started and continued till 10 pm intermittently, paralyzing civic life in the absence of electricity and the non-functioning of Wasa pumping stations. The rainwater flooded all main roads, roundabouts and low-lying localities.

As per Dawn, the power breakdown struck the Hyder-

abad region, particularly Hyder abad city, prompting the district administration to struggle to clear rainwater from main roads and roundabouts. Pakistan's Met Office recorded

around 50 mm of rain in Hyderabad city. It also rained in Hala, Matiari, Tando Allahyar, Jamshoro and Nawabshah.

Moderate rain soaked the city of Mirpurkhas and other district towns intermittently turning main roads and streets into pools of water and flooding all depressions and lowlying areas.

In some low-lying localities, rainwater entered a number of houses, forcing the families to shift to safer places. Rainwater could not be drained from the roads and streets as the pumping stations did not function without a power supply.

Many motorbikes and cars stopped functioning while trying to navigate through the rainwater, according to Dawn. (Milap News Network)

Moon-bound Chandrayaan-3 DGCA received applications gets farther from the earth on voyage

CHENNAI: India's moonbound spacecraft, Chandravaan-3. travelled further towards its destination with the Indian space agency on Tuesday raising its orbit further for the fifth time.

On August 1, the Chandrayaan-3 will take the 'moon spaceway' when the Indian Space Research Organisation (ISRO) will guide it to the TransLunar Injection (TLI).

On Tuesday, the ISRO said: "The orbit-raising maneuver (Earth-bound perigee firing) is performed successfully from ISTRAC/ISRO, Bengaluru. The spacecraft is expected to attain an orbit of 127609 km x 236 km. The achieved orbit will be confirmed after the observations."

"The next firing, the TransLunar Injection (TLI), is planned for August 1, 2023, between 12 midnight and 1 am IST," the ISRO said.

to de-register 54 aircraft leased to Go First: Govt

NEW DELHI: The government said on Monday that the Directorate General of Civil Aviation (DGCA) has received applications from lessors for de-registration of 54 aircraft leased to Go First, adding that processing of the applications by the DGCA is subject to the outcome of the cases lying before the National Company Law Tribunal (NCLT)

and Delhi High Court. In a written reply in the Rajya Sabha, Minister of State for Civil Aviation, General (Retd.) V.K. Singh said that Go First has submitted its resumption plan to DGCA for operating 150 flights daily with 26 aircraft.

"The DGCA has been closely monitoring the situation since the announcement made by Go First on May 2 to cancel its flights and its application for insolvency filed under Section 10 of the Insolvency and Bankruptcy Code (IBC).

"In the wake of suspension of operations by Go First, airlines have been advised to self-regulate

the air fares and maintain reasonable price levels and also to introduce new flights on the sectors that had a substantial number of Go First flights," the minister said

Bangladesh **Dengue Death Toll Jumps To 185**



Dhaka: The death toll from the viral dengue outbreak in Bangladesh has risen to 185 so far this year, while reported cases have reached 35,270, the Directorate General of Health Services (DGHS) reported

According to the figure reported by the DGHS under the Ministry of Health, 27,292 more dengue cases were recorded during the first 24 days in July after 5,956 people were infected with the mosquito-borne disease last month.

Greek Govt Pledges Support To Fire-Affected Areas

ATHENS: The Greek government has pledged its full support to fireaffected areas of the country, with several wildfires still continuing to rage as of Tuesday.

'We will rebuild all that was lost, compensate those affected," Xinhua news agency quoted Prime Minister Kyriakos Mitsotakis as saying during a debate in Parliament on Monday.

While welcoming his Bulgarian counterpart Nikolai Denkov, who is currently visiting Athens, Mitsotakis also thanked Bulgaria for helping Greece to battle the devastating forest fires that hit the country in July

"These are (...) unfortunately the real consequences of climate change. We have another difficult summer ahead of us, but we are doing the best we can," Mitsotakis

3 Palestinians **Killed In West Bank**



RAMALLAH: Three Palestinians were killed on Tuesday by Israeli soldiers in the city of Nablus in the north ern West Bank.

The Israeli troops stormed a vehicle and opened fire, Xinhua news agency quoted Palestinian security forces as saying.

The forces also claimed that the soldiers prevented Palestinian ambulances from reaching the vehicle.

An Israeli army spokesman told state media that the troops killed the three armed Palestinians after they opened fire at an Israeli army checkpoint near the city of Nablus.

According to the spokesman, the three militants arrived at an area near the checkpoint and opened fire from a distance of 100 metres at the soldiers who were stationed there.

A total of 2,293 fresh dengue cases including 1,238 in Dhaka were reported in the 24 hours till 8:00 a.m. local time Monday, the DGHS data showed.

DGHS said 27,622 dengue patients returned home after receiving treatment from various hospitals across the country from Jan. 1 to July 24 this year.

Death Toll From Algeria Wildfires **Rises To 34**



ALGIERS: The death toll from the raging wildfires in Algeria has increased to 34, including 10 soldiers, the Interior Ministry said in an update.

The Ministry said some 8,000 people were battling the blazes across 11 provinces, supported by 529 trucks and several firefighting helicopters, reports Xinhua news agency.

The fires started overnight on Sunday mainly in the provinces of Bejaia, Jijel, and Bouira, but quickly spread due to strong winds, causing significant damage.

As of Tuesday, a total of 97 fires were raging in the forests of 16 provinces.

5.5 Magnitude **Quake Hit Turkey**

ANKARA: A 5.5-magnitude earthquake struck southern Turkey on Tuesday, the European-Mediterranean Seismological Centre (EMSC) said.

The earthquake was recorded at 08:44 local time (05:44 GMT), with its epicenter located 65 kilometers (40.3 miles) from the city of Osmaniye and 20 kilometers (12.4 miles) from the city of Kozan in southern Turkey, the EMSC said. The depth of the quake was estimated at 10 kilometers (6.2 miles).

The head of the Disaster and Emergency Management Authority (AFAD), Yunus Sezer, said later in the day that there were no casualties from the earthquake.

At the moment, there are no negative situations after the magnitude 5.5 earthquake that occurred at 08:44 in Kozan district of Adana province," Sezer said on Twitter.

According to monitoring data on the EMSC website, this earthquake was the strongest among a total of six earthquakes that struck the area since 05:00 local time (02:00 GMT)

The AFAD also said that the quake could be considered as one of the aftershocks of the deadly earthquakes that hit Turkey on January 6.



Speaking of the Peacebuilding Commission, he said that 18 years after its creation, the commission "is strategically placed to help the UN keep pace with today's evolving threats'

As an advisory body to two key UN institutions, he said, the commission has unique chances to advance coherence and assist both the General Assembly and the Security Council in fulfilling their mandates

"The General Assembly could benefit from more substantive advice on specific situations, as well as on cross-cutting issues, such as the water crisis, which are major drivers of violence," he said.

"For this end, I suggest that the PGA (UNGA president) and the chair of the Peacebuilding Commission should hold regular consultations, similar to those with the presidents of the Security Council and Economic and Social Council, he added.

Korosi said that from war and violent extremism to the triple planetary crises of climate change, pollution and biodiversity loss, "global developments are demanding that we invest more in the peaceful future we aspire to achieve.'

"The suffering we see -- from North to South, and East to West -- offers clear proof that the costs of our inaction far outweigh the price of proactive investment in prevention," the UNGA president stressed.

In 2022, the Peacebuilding Fund approved record levels of support to 37 countries, according to Korosi.

He further mentioned that in the previous General Assembly resolution, member states confirmed their commitment to exploring all possibilities for sustained financing in peacebuilding.

"In this spirit, I urge you to contribute to the fund. To reflect that, if no progress is made today, our goal to save lives will remain elusive tomorrow. We know we are paying too steep a price for conflict."

He expressed the hope that the debate would inspire innovative ideas to strengthen collaboration among all stakeholders at every stage of the peace continuum.

MUMBAI: In a major development for Mumbai, the BrihanMumbai Municipal Corporation (BMC) has awarded the tender for constructing the Dahisar-Bhayander Elevated Link Road project to the lowest bidder, Larsen & Toubro, an official said here

on Tuesday. The L&T will build the DBLR at a cost of Rs 1,981 crore within 42 months and it will be the final link of the upcoming Mumbai Coastal Road Project which will be

Municipal Commissioner P. Velarasu said it will provide a better and faster alternative to cover the distance in just 10 minutes without hassles on a signal-free road along a bridge and two inter-changes. The BMC heads added that after completing the BMC's project, the L&T will also be responsible for its maintenance for three years. The project includes a 5-km-long, 8-lane, 45 metre wide bridge, linking Dahisar (Mumbai) with Bhavander (Thane). with 1.5 km falling under the BMC and 3.5 km under the

infrastructure project, it will reimburse the MBMC expenses on it through the Mumbai Metropolitan Region Development

Authority (MMRDA). Presently, only rail connectivity is available from the western suburbs between Dahisar suburb and Bhayander town. Now, a steel bridge will come up in the Dahisar Bay area, and another 350 pillars will support the 5 km of elevated cement-concrete road, with two interchanges at both ends.

Paris 2024 unveils design of Olympic and **Paralympic Games torch**

PARIS: With almost a year to go for Paris 2024, the organisers unveiled the design of the Olympic torch for the Olympic and Paralympic Games in the headquarters of the Organising Committee, here on Tuesday.

The torch has been designed by French designer Mathieu Lehanneur, who drew inspiration from three themes of Paris 2024 for the torch: equality, water and peacefulness, to reflect the upcoming Games

"Equality is symbolised by perfect symmetry. Water is symbolised by the wave, relief and vibration effects. Peacefulness is symbolised by the gentleness of the curves," said Lehanneur.

The torch will be carried by 11,000 Forerunners as the Olympic Torch Relay.

After being lit by the rays of the sun in Olympia, Greece in accordance with ancient tradition, the



Olympic flame will arrive in France after crossing the Mediterranean Sea.

In Marseille, on May 8, 2024, the Flame from the Paris 2024 Torch will open the Games with the Olympic Torch Relay until the Paralympic Games Closing

Ceremony. After two weeks of sporting action, the Olympic flame will be extinguished

but the torch will live on. As a symbol of the connection between Olympism and Paralympism, it will be lit once again in Stoke Man-

DC Ganderbal chairs 13th NCORD meeting

GANDERBAL: The Deputy Commissioner (DC) Ganderbal, Shyambir Tuesday chaired a 13th meeting of the Districtlevel NARCO Coordination Committee (NCORD) to review the measures taken by the enforcement agencies to curb the drug abuse and narcotic trafficking in the district.

During the meeting a threadbare discussion was held on various issues pertaining to incidence of drug addiction, areas of concern and hotspots of drug use and action taken

by the concerned departments with regard to curbing the menace of drugs.

The DC sought realistic data from all stakeholders regarding the status of drug addiction and culti-

vation of restricted crops. While reviewing the status of cultivation of cannabis in the district, he directed Tehsildars to collect the data of cannabis cultivation, drug addicts and drug suppliers in their jurisdiction taking help of patwaris, chowkidars and lumberdars so that appropriate action is initiated accordingly Assistant Drug Controller informed that out of total 257 retail medical shops in the district, over 70 percent of shops have installed CCTV cameras. Further about 31 percent of shops have installed computerized billing systems.

The DC directed her to intensify inspection of chemist shops to restrict illegal transport, sale and distribution of psychotropic drugs and other banned substances in the district besides ensuring 100 percent installation of CCTV cameras by all medical shops and switching to computerized billing systems by all shops.

BANDIPORA: Three houses including six shops were destroyed while an elderly lady was injured in a massive fire in the remote Kudhara village of north Kashmir's Bandipora on Tuesday.


An official said that the fire broke out from one of the houses and rapidly spread to the neighbouring structures, resulting in damage to three residential properties. However, the cause of the

"In the incident, properties worth lakhs of rupees were destroyed, and an 80-year-old lady identified as Noor Bagum was also injured." he said, adding that the lady was shifted to a nearby hospital for treatment.

The official said three houses that were completely destroyed belonged to the brothers. Noor Hussain and Muneer Hussain, along with their uncle Mushtaq Ahmad Khan

There was also a structure that housed six shops, all of which have been reduced to rubble, he said, adding that the shops included medical and veterinary stores, a food store, and a Kirvana store. After visiting the location and assessing the extent of the damage, the district authorities offered assistance to the affected families. An immediate financial aid of Rs 10.000 was provided to each family along with three kitchen sets for their essential needs.—(KNO)
