Doodhpathri Breaks Records, Attracts 2.6 Million **Tourists In 9 Months**

SRINAGAR: Doodhpathri, once a hidden gem nestled in the heart of central Kashmir's Budgam district, has undergone a remarkable transformation, evolving into a mustvisit tourist destination. In just nine months, this scenic spot has broken records, attracting an astonishing influx of over 2.6 million visitors from various parts of the world. Nargis Suraya, Chief Executive Officer of Doodpathri Development Authority (DDA) credited the area's recent surge in popularity to years of development and hard work. She said the restored network facilities have encouraged people to visit. even for overnight stays.

"In the last nine months Doodhpathri welcomed 2.628 million visitors,

including 2,826 international tourists. This surge indicates that the place has rapidly become a mustvisit spot in the Kashmir Valley," she said, adding that during the first four months of this year, nearly 200,000 people visited, but in the nine months since, the number has surged to 2.6 million.

SRINAGAR: The Department of Psychology and Psychological Counselling Cell Amar Singh College Thursday kick-started week-long programmes for observing 'Mental Health Awareness Week' focusing on this year's theme 'Mental Health is a Universal Human Right'.

Dr. Ulfat Jan, Head Department of Psychology emphasized the need to acknowledge mental health issues as human rights issues and contended that all general human rights treaties apply to people with mental illness.

A lecture on Mental Health and Drug Abuse was delivered by Dr. Mehvish Registrar Institute of Mental Health and Neurosciences (IMHANS) and the expert was invited for the occasion.

Dr. Mehwish deliberated on the issue of substance use and its repercussions for mental health. She argued that the cooccurring disorders may further deteriorate the situation of the sufferer. She stressed the need to take substantive mea-

sures to ensure the eradication of concurrent disorders.

as the drive will continue in the coming days as well, and we have identified many spots in different areas of Srinagar," said the head of the Child Welfare Committee (CWC) for Srinagar, Dr. Khair-un-Nisa. She said that on Wednesday 14 children including four girls (all of them minors), and they have been sent to the shelter homes of CWC. "Once we take the child with us, their parents or legal guardians reach out to us, and after legal formalities and counseling, we follow up with the procedure. For those children who don't have parents or legal guardians, we become their custodians, and we take care of their schooling under other schemes provided by the central government," said Dr Nisa. When asked about mostly outsiders being involved in begging and child labour, Dr. Nisa said, "For us, a child is a child, whether they are locals or non-locals. Once we receive information about child labour or begging, we visit the spot and rescue the child. Every child has its rights, and we have to safeguard them," said Dr. Nisa while adding that this stage of a child is the golden age and needs to be optimized for schooling and building a career. She further said that, "for the general public, if anybody wants to raise a complaint about child labour, child trafficking, or child begging, they can reach our office at Bemina, Srinagar, contact us through social media platforms, or call us on our toll-free number: 1098 To a query that police and security officials accompanying them may scare the child, Dr. Nisa said: "The police protection is for our assistance, and the public is supporting us, with a very positive response, and its the responsibility of the special jewelle police unit to rescue the children itself, to maintain the law and law. Once we come to rescue, we need a police party along with us because if the child doesn't want to come with you, that's when the role of the police comes in, and the complaints about child labour and child trafficking are coming from the public. Explaining about the drive, Dr Nisa said: "When the drive in a selected area is started, they, along with the labour department and police officials, conduct the operation and rehabilitate the children involved in begging, child labour, and child trafficking. The police officers accompany us to ensure the rescued children so that they can be safely handed over to our shelters."—(KNO)

"More than 2.50 lakh people were recruited in the past through backdoor channels. What type of system is this? No one should rely on backdoor channel entry. All of this has come to an end now. Those who deserve jobs and those who don't should look for alternative work to earn a livelihood," the CS said.

He suggested that youth need to think big rather than relying on daily wage jobs.

He said that the water supply will reach every remote place by the end of this year. "People need to keep a check while work is going on since no such scheme will come early years. By the end of the year, the aim is to achieve 100 % work done in this regard."

The CS said that J&K has borrowed power of 31,000 crore rupees. "Even after giving a 50 per cent subsidy, we are not able to get even 20 percent of the charges from consumers. They don't pay monthly payments."

He said that 24-hour power supply can be a reality in the entire J&K only if people cooperate. "If 100% payment is done by all, we will get 24-hour power supply across the region. People need to be responsible and make 24 supply a reality for that people need to pay their bills timely," the CS said.

On the education sector, the CS said that students need to at least qualify 12th standard in this era of education. "If there are problems or some challenges all of them can be mitigated. We need to make sure that our youth is well educated."

About the health sector, he said that people need to make golden cards. "It is very beneficial for everyone. Till now about 7% of cards are pending individually."

Referring to the importance of sports, he said that grounds have been made in each panchayat across J&K. "Everyone needs to take part in the sports activities."

On Nasha Mukt Bharat, he said that it is being ensured and everyone should stay away from such practices.

Referring to the achievement of J&K, the CS said that our region has been able to record 100 per cent digitization. "We are now number one across the country. There is no need to visit offices anymore. All services, schemes, and information are available on mobile which is just a click away. About 900 services are available now online. No government official can show any incompetence in working on grievances filed online. We have so far made about 1,000 officers pay fines for not responding to online queries," he said.



SRINAGAR: Addressing the pressing issue of smoking and tobacco consumption in Jammu and Kashmir, Advisor to Lieutenant Governor. R R Bhatnagar on Thursday emphasised the significant challenges posed by this problem, revealing that approximately 70 percent of the population in the Union Territory are passive smokers.

Speaking at a media workshop in Srinagar, Bhatnagar, highlighted the alarming statistics. He pointed out that the incidence of smoking in J&K is alarmingly high, with passive smoking affecting 70 percent of households and 60 percent of offices.

Bhatnagar stressed that tobacco use is the leading cause of preventable deaths and called for unified efforts to eradicate this menace. He emphasised the importance of educating young people about the adverse effects of tobacco consumption, including its potential link to alcoholism, cannabis use, and other drug-related issues. 'We must act urgently on a war footing basis; it is critical for the well-being of our



citizens and the future of our region," he added.

Bhupinder Kumar. Administrative Secretary of the Health and Medical Education (H&ME) department, echoed Advisor Bhatnagar's concerns, saying that tobacco consumption, both through smoking and non-smoking methods, remains a significant challenge in J&K.

He said smoking is Tobacco Products Act) a major risk factor for regulations. Dog Bite Cases

he number of dog bite cases in Kashmir is increasing at an alarming pace. Dogs are everywhere, almost everywhere - in every road, lanes and warrens. There is one roundabout in Jawahar Nagar area of uptown Srinagar where a prospective filmmaker can shoot a horror movie unedited – the place of a mere 50 square meters has hundreds of dogs squatted right in the middle of the road ready to pounce on anyone who dares to walk alone during evening and night hours. According to a report released to the local press an alarming 4,396 bite victims, mostly dog bites, were reported to the Anti-Rabies Clinic at Srinagar's SMHS Hospital in the last six months this year. And if we take a full financial year into consideration from 1st April 2022 till 31st March 2023, as many as 6,875 bite cases were reported. This is beyond belief. The dogs in Kashmir appear to be well-fed due to the non-vegetarian food inclination of the citizens of the valley. They are usually flocked around the shops and butchers waiting for them throw a few offals at them. We appreciate the efforts of the state administration in as far as sterilization efforts are concerned. However, this sterilization drive seems not have met with the intended success. The government can rope in more volunteers, provide them with basic training and this way intensify that process. The Srinagar Municipality Corporation had used a technique of relocating the dogs to a few sub-urban areas on the periphery of Srinagar – a move which has already led to a few fatal attacks in the paddy fields. We expect that the government would seriously pursue this case as these thousands of people are losing thousands of work hours to the treatment of dog bites. Besides, the presence of so many dogs on almost every street is creating a fear psychosis. We hope government has a plan in offing to lower the number of dog attacks. Srinagar city deserves an environment where one could walk freely during evening hours or go freely to places of worship at the cusp of dawn.

Understanding The School Based Assessment (SBA)

chool-based Assessment is the assessment conducted by the teachers in the schools they teach in. The subject teachers continue to assess their students throughout the session and thus teaching, learning and assessment go hand in hand in an integrated manner. It is a learner-centric methodology and activity-based pedagogy. It is different from the traditional method of examinations and assessment. It is a repetitive method that continues throughout the session in order to narrow down all the learning gaps in the students.

In its wider sense, SBA includes assessment for learning, assessment as learning and assessment of learning. The main motive is what is called the all-round development of the learners in a more effective and efficient manner. It assesses the learners both formally as well as informally. One of the basic features of SBA is that it leads to collaborative learning. It lends more emphasis on understanding the concepts. Because the New Educational Policy 2020 also stresses the concept of understanding of the learners.

School-based assessment does away with traditional and faulty methods like forcing the students to learn under the threat of examinations. It

is not merely about labeling the learners and dividing them into Slow learners, bright students problem children etc. Its main aim would be to identify the learning gaps in conceptual understanding and employment of the sophisticated methods to narrow down those gaps. It inspires the learners to provide friendly feedback to enrich learning in a proper learning environment. The traditional method of assessment left all stress on the written examinations which only forced students to memorize too much even without bothering about the concept clarification. The experts later came to realise that this way of learning could not be beneficial to the students in the long run. SBA thus believes more in formative assessment which shall assess the basic learning of the students and their concept clarification in every subject, topic and lesson

throughout the session. It shall be more beneficial, efficient and comprehensive in bringing real change in the teaching-learning process.

School-Based Assessment combines the main features of both formative and summative assessment in a proper manner. Although it gives more importance to formative assessment, the features of summative assessment too are added in order to bring better results. It believes in classroom-based sessional assessments throughout the session to keep the students alert and active during the teaching-learning process. Formative assessment occurs during the learning process while summative assessment begins at the end of the process. Formative assessment allows the teachers and the learners to pivot the strategies mid-stream while summative assessment provides final evaluation of knowledge and skills

taught and learnt. Formative assess ment identifies the areas of improvement while the summative assessment identifies the areas of concern. During the formative assessment, the students give their feedback while after the summative assessment, the students are provided with the grades.

Thus, by including both types of assessment properly we can witness a revolutionary change in the whole education system. If the teachers are able to learn and implement the SBA properly and wholeheartedly there can hardly be any doubt that skies would be our limits as far as our formal education system is concerned. It will certainly lead to learning that would be holistic, integrated, enjoyable, and engaging for the learners.

Specially-Abled: Time To Part With **Cumbersome Policies**

ollowing the latest order in letter and spirit entailed that the differently-abled were made to wander from pillar to post to get their documents verified like Unique Disability Identity card (UDID), which a person could get only at certain places; a document to be verified at the concerned Bank authorities; an affidavit from a first-class magistrate; and an e-ticket from food and civil supplies department - and the list is endless. A while back, the govern-

ment issued an order for specially-abled persons to get their document of disability re-verified. The purpose of this order was to expose the corrupt elements. Basically, a lot of people had registered themselves as disabled when in reality they were physically fit.

On the one hand, it was a good initiative to expose those masquerading as handicapped. On the other hand, it was the beginning of a hectic process for the genuinely differentlyabled as they had to navigate a hugely bureaucratic set up. They were made to wander from pillar to post to get their documents verified like Unique Disability Identity card (UDID), which a person could get only at certain places; a document to be verified at the concerned Bank authorities; an affidavit from a first-class magistrate; and an e-ticket from food and civil supplies department - and

the list is endless Another major problem faced by them was that they could not afford help from a relative or a friend; they had to do it themselves. The burden of the 'Bio-Metric' lay on their head as did everything else. They had to visit each department multiple times to get their documents verified. The time-gap between the appointments (visits) was in itself

frustrating. For example, to get a UDID card, a speciallyabled person had first to visit the concerned department to book the appointment. Almost after a week or two, he again was supposed to visit it to get his Biometric done. The third time, he had to visit the local computer operator to get it downloaded or printed out. Similarly, they were to get an E-ticket from the food and civil supplies department. They had to submit the documents on the first visit and almost after ten to fifteen days, e-ticket was issued in their favour.

The sufferings of speciallyabled people did not end here. Not only did they have to wait for almost half a month to get the documents verified, but also the buildings of these institutions or departments were in itself a major hurdle as in a lot of them the elevators or lifts were either non-existent or malfunctional, adding to their suffering. They had to go to either the first or second floor of each department to get their

work done. They had to wait until a bunch of people would come and lift them in arms (or through either through their wheelchair) to get them to their concerned room for documentation. After completing the formalities, they again had to wait for people to get them down stairs.

This process of them being lifted by other people was emo-tionally taxing for them as it forced them to seek help from others all the time.

Also, they had to wait in line for a long time to get their appointments. I remember, when I had to visit the Medical Board at Jawahar Nagar to avail the signature of a concerned medical officer for scholarship. I saw a queue of around fifty to sixty people waiting outside for their turn. One among the reasons for that larger queue was that the Medical Board used to be open on only two days in a week, adding to their misery. In case, if any person fails to fulfil prescribed formalities, he or she has to go through the same haphazard process of waiting a month to get the appointment.

It is not only the fault of those various institutions, but the state too is responsible. Changing the name of disability to specially-abled is not enough. Delivering speeches on disability day won't improve their condition. No doubt the state took this step to bring transparency and allow the real beneficiaries to avail benefit. But the manner of its implementation was not people-friendly.

Postscript:

- It is the collective responsibility of society to not let them feel that they have any disability.
- The state must restructure the layout of their buildings, shifting the main office to the ground floor or making special arrangements so that the specially-abled person will not suffer to get their work done.

- The criteria to avail the various documents must be simple and easy.
- Their work must be given a top priority to avoid frequent visits.
- A separate department apart from the social wel-fare department must be there that is linked with all the concerned institutions or departments, so that specially-abled people need not visit various departments to get their work completed.
- No doubt there are numerous NGOs who tirelessly work for improving the standard of speciallyabled persons. Still, there are deficiencies and loopholes about their policies - and it require immediate attention.

Ending TB One Barangay At A Time

earing testimony to this, a small group of people in Bantayan Municipality of Cebu, Philippines, has changed the lives of many people affected by tuberculosis (TB). TB, despite being preventable and curable, continues to be the deadliest of the infectious diseases in high TB burden countries.

Carrying innovative new diagnostic tools for TB in plastic tubs, they went from islet to islet on pump boats, braving inclement weather, to screen and diagnose people with TB. This resulted in a tremendous increase in TB case finding upfront: 316% rise in new TB case detection, and 1292% rise in screening of those with presumptive TB.

Imagine the difference it can make in the Philippines' fight to end TB if such interventions can be scaled up and become a norm.

As per the latest Global TB Report 2022 of the World Health Organization (WHO), out of the estimated 741,000 people with TB in the Philippines, only 321,600 were notified to the national programme, and over 60,000 lives were lost due to TB.

As of now, only 43 out of every 100 people with TB are reached by the TB services in the Philippines, and only 65% of those reached, get a WHO recommended molecular test diagnosis, while the rest get a smear microscopy (which underperforms in TB diagnosis), or get treated without any bacteriological confirmation.

As early and accurate TB diagnosis is the gateway to TB care pathway (and breaking the chain of infection transmission), the Philippines has a two-fold task:

Firstly, it must ensure that it is reaching out to all those with TB (and not just 43/100), and

Secondly, it must use WHO recommended molecular tests to diagnose TB timely and correctly. This paradigm shift in TB diagnostics is





The Fujifilm ultraportable x-ray and Truenat molecular testing machine do not require laboratory infrastructure. "We were out in an open field and the barangay officials had just put up tents. We used a shower curtain as a makeshift screen for x-ray. It was like setting up a photo booth anywhere for the ultraportable x-ray," she said.

ultraportable x-ray," she said. On 16 September 2022, her team recorded the highest TB case finding rate of 14.4% in Kabac. Narrating her experience of travelling to Hilotongan where travel is difficult due to low tide, her team began at 6am in the morning to reach there on time. TB case notification rate was 12.3%. They used a local church facility to set up the x-ray and molecular testing equipment.

Her hardest travel was to Luyongbaybay on 30th September 2022 for which she and her team had to leave at 3am when it was high tide (if it is low tide then they cannot cross the sea as the boat gets stuck). TB screening and testing was done right outside the day-care centre and inside a gym. "I was the only

paradigm shift in TB diagnostics is a critical entry point, not only to the full spectrum of TB care cascade, but also towards ending TB in the country.

Ending TB – one barangay at a time with x-ray and Truenat

When the WHO recommended point-of-care, decentralised, laboratory independent and battery operated molecular test Truenat (made by Molbio Diagnostics), along with the ultra-portable and battery operated x-ray made by Fujifilm, was deployed in Bantayan islets, new TB case notifications, as well as treatment success rate, increased manifold, confirmed Dr Samantha Tinsay, Municipal Health Officer, Bantayan Municipality, Cebu, Philippines. "TB is a disease of poverty. Unfortunately here in our island of Bantayan a lot of people have TB because of malnutrition and poor hygiene," she said. Malnutrition is the biggest risk factor for TB.

Using latest and state-of-the-art diagnostic tools in the Philippines was made possible in 2022 by introducing New Tools Project (iNTP) of the Stop TB Partnership and United States Agency for International Development (USAID), which has helped in the rollout of a package of latest innovations in diagnostics, treatments, and digital health technologies to strengthen TB care in high burden countries.

Bantayan is the largest municipality of Bantayan island and it has 25 barangays (small townships) and one district hospital which is understaffed and undersupplied. These areas are also marked as geographically isolated and disadvantaged areas (GIDA). Most of the people here are fisherfolk or farmers and their income is Pesos 300-350 (USD 6-7) a day.

"During September to October 2022, we were able to screen 1774 people with presumptive TB by bringing these tools right to their doorstep. Most of them cannot afford to travel to the mainland for diagnosis or treatment. When Dr Samantha Tinsay began the introduction of these new innovative diagnostic tools in September 2022, extreme climate events- such as typhoons and storms- compounded the challenge. But it was sheer determination on her and her team's part to hop on a pump boat and brave the storms and typhoons to go from islet to islet and find TB, and treat TB.

"When we started this project in September 2022, it was the middle of the typhoon season. So one of the challenges we often faced was the bad weather conditions. It took a lot of teamwork and effort with my staff and the barangay healthcare workers and officials of the local health unit - It was an all-in-one effort supported by the community," shared Dr Tinsay.

The x-ray and Truenat molecular test were brought to the Bantayan Rural Health Unit, and packed in a suitcase with wheels for transportation. Both of these machines fitted well in a moulded plastic tub, and were transported via pump boats.

On 29 October 2022, Tropical Storm Nalgae, locally known as Paeng, hit the Philippines, and affected around 4.8 million people within a week. On that fateful day, Dr Samantha Tinsay and her team were en route to one of the islets with the diagnostics tools in tow. "We did not know that a storm signal had been raised, and that nobody should be travelling or working as we were out of the range of mobile signal. Nevertheless, rain or sunshine, we were working and could of people who got tested for TB also went up from 180 people in 2021, to 2506 people in 2022 (an astronomical increase of 1292%).

"TB treatment success rate has also increased to 97% in 2023,"she confirmed. Average TB treatment success rate in the Philippines was 76% in 2021 as per the WHO report.

"These new innovative TB diagnostic tools are very crucial in the fight against TB, especially for people living in geographically isolated and disadvantaged areas (GIDA). These tools can really help eradicate TB. Bringing these tools to the people in a country like the Philippines where TB is very rampant, will help end TB, one Barangay at a time," rightly said Dr Tinsay.

TB diagnosis before the new tools were introduced in Bantayan

"I started working in Bantayan in November 2021. Prior to that the method of screening for TB was inefficient and also expensive for the people. We had the Gene Xpert machine for molecular testing. But getting the x-ray done was a challenge for the patients as they did not want to pay Pesos 350-450 extra for the x-ray. It was more than their income for one day. In 2022, (before the Truenat molecular test or portable x-ray came), we started a partnership with an NGO called the Philippine Business for Social Progress. They provided free chest x-ray vouchers, which was very helpful. But the hurdle was that the people did not want to pay the boat fare to go to the x-ray labs. Now we have more partners, including Christian

able x-ray. They are the real pointof-care screening and confirmatory tests for TB that we can do right at the doorstep of people and can schedule it anywhere anytime!" said Dr Tinsay.

The barangay health workers checked the vital signs of the persons, the community nurses took the persons' medical history and did their registration. Then, the radiology technicians took the chest x-ray. "If the chest x-ray was positive, then molecular testing of sputum was done by the medical technologist, using Truenat molecular test machine, and they were accordingly referred to doctors to begin medical treatment on the spot, as well as for provider initiated counselling and testing for HIV. We also did HIV testing on the spot on the same day, as we know that a lot persons with HIV are also co-infected with TB. We wanted to end the stigma and the frustration of the patient by offering the tests on the spot," she added.

Artificial intelligence

The portable x-ray uses artificial intelligence to read TB and shows a red spot if there is TB.

Recounting her experience of intensified TB case finding, Dr Tinsay shared that "On 6th of September 2022, our first stop was at Sayao in Bantigue barangay, which has one of the highest cases of TB in this barangay. Here we tested 117 patients out of which 7 were confirmed positive for TB, a case detection rate of 6%. All this was done on the same day. We started at 8am and finished at ~5pm.

doctor there and I checked 238 patients from 6am until 4 pm. We also provided free blood sugar testing and some paediatric check-ups, she said. "This was the maximum number of patients we checked in one day, thanks once again to the teamwork and very supportive barangay officials. Before we arrived, there was a thunderstorm, so we were soaking wet (drenched) when we reached this Barangay. We were not carrying any change of clothes with us. Once again, the barangay officials and the people of the islet were very supportive (and gave us free t-shirts to wear).'

"On an average we were testing 70 to 120 patients in a day, using these new tools. Every barangay that we went to, there was at least one positive case of TB. Nowhere was there zero case detection," she told.

The future ahead

In Bantayan island there are 3 different municipalities. Bantayan is the largest, and the other two are Santa Fe and Madridejos. "If we get the innovative New Tools Project back, we are willing to share the case findings with the other two municipalities, just as we did last year," said Dr Tinsay.

"Just two days ago we had a patient living with HIV, who also had TB, who passed away at the age of 24 years. This should not happen anymore. A lot of people do not seek help because of the TB stigma, and because the diagnostic tools are at such far flung places and out of reach for them. By bringing pointof-care testing at their doorstep, we can help end TB- one barangay at a time," she summed up.

Representatives of Administrative Departments of Finance, Forest, Environment & Ecology. Revenue, Science & Technology, Tribal Affairs, Rural Development and Panchayati Raj, Agriculture Production and Farmer Welfare, Planning & Monitoring participated in the meeting. Senior Officers of Forest and allied Departments including Chief Wildlife Warden, Addl. Pr. Chief Conservator of Forests (Forest Conservation Act), and Chief Accounts Officer attended the meeting.

Special invitees including APCCF Jammu, APCCF Kashmir, CF

North, South, Srinagar, Chenab, West and East Circles participated, nonofficial members, Nazir-Be-Nazir (NGO Member) and Ch. Asaf Iqbal, Expert on Tribal matters, also participated in the meeting.

PCCF & HoFF, J&K Forest Department in his opening remarks gave an overview of the main activities of CAMPA. He informed that under "Green Jammu and Kashmir Drive/Green India Mission", a record number of plants are being planted with the people's participation. In the current year, the department has enhanced the target of planting from 1.50 to 1.75 Crore plants.

He explained the importance of digitization of old demarcation records and the need for strengthening the boundary lines of vulnerable forests by erecting robust boundary pillars.

He made a reference to the decision taken by the Steering Committee in its meeting held on 23.01.2023

to scale up the work of demarcation of remaining forests to secure the vulnerable forest land from encroachment

He informed that recently the J&K Government has issued directions vide No.FST-PCB/7/2021-02 dated 08.08.2023 to the forest department to complete the work of Digitization, Survey and BP fixing in all vulnerable category of "Forests" by end of March 2024.

The Chief Executive Officer, CAMPA, Asaf Mehmood Sagar made a presentation on the progress of implementation of the approved Annual Plan of Operation (APO) of 2023-24 and the additional APO for 2023-24 under CAMPA. He informed that against the current years' afforestation target of 13719 ha area, 4461 ha area stood planted with 18.50 lakh plants. He presented the agenda of the meeting before the Committee.

After detailed discussions, the proposed Addi-

tional Annual Plan of Operations for 2023-24 was considered and recommended by the Executive Committee for approval of the Steering Committee for onward submission to the National Authority, Ministry of Environment, Forest & Climate Change, Government of India for final approval.

BENGALURU: India's fintech sector saw a 68 per cent surge in funding in the July-September period (Q3) from the previous quarter, as the country became the fourth-highest funded fintech startup ecosystem globally, a report showed on Thursday.

Indian-origin NASA scientist to lead rocket mission into 2023 solar eclipse

WASHINGTON: An Indian-origin scientist at NASA is helming a mission that aims to launch three rockets during the 2023 annular eclipse on October 14.

The mission, known as Atmospheric Perturbations around the Eclipse Path or APEP, is led by Aroh Barjatya, will study \oplus how the sudden drop in sunlight affects our upper atmosphere, the space agency has said.

On October 14, people viewing the annular solar eclipse will experience the sun dimming to 10 percent its normal brightness, leaving only a bright "ring of fire" of sunlight as the moon eclipses the sun.



Indian gaming platform WinZO enters Brazil amid 400% GST hike

WinZO will invest \$25 million in Brazil in distribution and branding for more than 100 partner game developers.

"We have built a tech stack that caters to over 150 million young users from Bharat today and can be scaled across the world," said Paavan Nanda, Cofounder of WinZO.

The decision to enter the Brazilian market is driven by a strategic approach to diversify and address challenges posed in India to all the companies by the 400 percent hike in GST in India, said the company.

This move will help the platform's partner game developers export games such as Carrom, Chess, Car Race etc, and gain free access to Brazil, the fourth-largest mobile gaming market with over 90 million users.

The partner game developers will get access to the

new market and users without any cost of technology, marketing, and distribu-

tion, said WinZO. Brazil has witnessed a significant surge in the popularity of mobile gaming with about 4.6 billion mobile game downloads in 2022.

The expansion came as companies explore ways to steer through challenges posed by a 400 percent hike in the GST, which threatens the survival of most content/IP creators in their nascent stages which have the potential to catapult India into a leadership position within the global gaming arena.

"It is noteworthy that taxation rates globally, including countries such as the US, the UK, Australia, and Germany, are applied to the commissions for casual games of Skill that are treated differently from Fantasy Sports," said WinZO.

Brazil levies indirect taxes such as 2-5 percent as municipal tax, applicable to the commission earned by the company. This month, WinZO will also launch and represent the first-ever India Pavilion at the Brazil Game Show, the largest gaming show in Latin America.

War causes over \$150bn damage to Ukraine's infrastructure

KYIV: Russia's ongoing war against Ukraine has caused \$151.2 billion in direct damage to the latter country's infrastructure as of September this year since the invasion first started in February 2022, a new study revealed.

According to the study by the Kiev School of Economics, the damages have increased by over \$700 million as compared to June 2023, from \$150.5 billion to \$151.2 billion

It revealed that the housing sector was the worst hit, amounting to \$55.9 billion.

In total, 167,200 housing units have been destroyed

or damaged as a result of the hostilities, comprising 147,800 private houses, 19.1 thousand apartment buildings, and an additional 0.35 thousand dormitories.

White House waives 26 federal laws to allow building border wall in Texas

HOUSTON: In the wake of a fresh surge of migrants influx, the White House has waived 26 federal laws to allow border wall construction in Starr County, Texas, the .S Department of Homeland Security

(DHS) said. It marks a U-turn of the Biden administration since building the border wall was a signature promise by former President Donald Trump in his 2016 campaign and has been fiercely criticized by the Democrats since then, reports Xinhua news agency.

President Joe Biden halted the construction during his first week in the

White House in Jan. 2021. "There is presently an acute and immediate need to construct physical barriers and roads in the vicinity of the border of the US in order to prevent unlawful entries into the United States in the project areas," DHS Secretary Alejandro Mayorkas said in a notice posted on Wednesday night on the US Federal Register, an office that prepares and publishes a wide variety of public documents.

Mayorkas said he is using his authority provided by Congress to waive these laws, including the Clean Air Act, Safe Drinking Water Act and Endangered Species Act.

Australians set to limit **Christmas shopping spree** under cost-of-living pressure

CANBERRA: Australia's top retail body estimated on Thursday that the pre-Christmas spending in 2023 is tipped to remain nearly the same as last year's results, as citizens have a tighter rein on their budgets due to the cost-ofliving crisis.

Provisional forecasts by the Australian Retailers Association (ARA) and Roy Morgan indicated a total of A\$66.8 billion to be spent during the November to December 24 Christmas trading period, up slightly by 0.1 percent from last year's level, reports

Xinhua news agency. Spending on food is projected to account for the lion's share, making up A\$26.7 billion of the overall spending and increasing by 2.4 percent compared

to last year. While department stores and other retailing, such as recreational goods, books, and cosmetics, are poised for a 2.9 percent and a 1.7

percent growth in sales. The categories of hospitality, household goods,

and clothing are bracing for a softening of spending in the lead up to Christmas.

Both South Australia and the Australian Capital Territory are set to have a growth of 1.2 percent in sales, followed by Tasmania, Western Australia, Northern Territory, and Victoria, with spending in Queensland and New South Wales predicted to fall.

ARA CEO Paul Zahra noted that a softening of spending on discretionary goods is expected given the current economic conditions and the persistent

cost-of-living crunch.

Turkish military conducts 3rd air operation against PKK in Iraq

ANKARA: Turkey's military carried out its third cross-border air opera tion into Iraq, after a suicide bomb attack in the capital Ankara.

Turkish Foreign Minister Hakan Fidan warned at a security meeting on Wednesday that all the outlawed Kurdistan Workers' Party (PKK) and the Syrian Kurdish People's Protection Units (YPG) infrastructure and energy facilities in Syria and Iraq are now "legitimate targets for the Turkish military".

Fidan revealed that the two assailants responsible for Sunday's suicide bomb attack in Ankara came from Syria. Turkish Interior Ministry identified the two attackers as PKK members, Xinhua news agency reported.

The PKK, listed as a terrorist organisation by Turkey, the US, and the European Union, has been rebelling against the Turkish government for more than three decades. Turkey also sees the YPG group as the Syrian branch of the PKK



Interior Ministry's building on Sunday resulted in the injuries of two police officers. During the attack, one suicide bomber blew himself up while the other was shot dead by the police.

The Turkish Armed Forces carried out two major air operations on Sunday and Tuesday against the PKK and destroyed 22 targets including caves, bunkers, shelters and warehouses in northern Iraq, said the Turkish Defence Ministry.

KHARTOUM: Nine civilians have been killed and 15 more have been wounded as a result of a strike on a medical center at a mosque in Khartoum Bahri, a city to the north of Khartoum, by the Rapid Support Forces (RSF) paramilitary group, Sudanese armed forces spokesman Nabil Abdallah said. "The dissolved rebel Rapid

Support Forces have shelled a medical center at a mosque in Bahri, having killed nine civilians and injured 15 others." Abdallah said.

The paramilitary group has yet to make an official statement on the shelling.

On April 15, violent clashes broke out between the Sudanese army and the RSF. Paramilitary commander Gen. Mohamed Hamdan Dagalo accused Abdel Fattah Burhan, the head of the Sudanese sovereignty council and commander of the armed forces, of being reluctant to hand over power to the civilian government. The parties to the conflict have since introduced a number of temporary nationwide ceasefires, but none has helped settle the conflict.

The UN estimates the death toll from the conflict in the hundreds, while the Red Cross has warned that extended hostilities risk



With the bat, hosts India have most number of 300+ totals after 2019 World Cup ended - at 17, followed by defending champions England and Bangladesh at nine respectively. In terms of batting second, New Zealand have most 275+ totals – at 11. followed by India at 10 and Pakistan at 8.

GENEVA: The FIFA World Cup 2030 is set to be cohosted by Morocco, Portugal, and Spain, with three other countries in South America also involved in staging games to celebrate the 100th anniversary of the event, according to FIFA.

The FIFA Council conducted a videoconference in Zurich, Switzerland, to confirm the sole candidacy,

which is a combined bid of Morocco, Portugal, and Spain. They will receive automatic qualification to the tournament if they complete a successful bidding process in 2024, Xinhua reports.

"The FIFA Council also agreed unanimously that the only bid to host the FIFA World Cup 2030 will be the joint bid of Morocco,

Portugal, and Spain," FIFA President Gianni Infantino was quoted as saying

Portugal, and Spain as co-hosts in the FIFA statement. "In 2030, we will have a unique global footprint, three continents - Africa, Europe, and South America - six countries - Argentina, Morocco, Paraguay, Portugal. Spain. and Uruguay

welcoming and uniting the world while celebrating together the beautiful game, the centenary and the FIFA World Cup."

The council agreed to host a centenary celebration ceremony in Uruguay's capital Montevideo, where the first-ever FIFA World Cup took place in 1930. Besides, Uruguay, Argentina and Paraguay will organise one match each of the FIFA World Cup 2030.

"The first of these three matches will of course be played at the stadium where it all began, in Montevideo's mythical Estadio Centenario, precisely to celebrate the centenary edition of the FIFA World Cup," FIFA said.



Dumping site fire causes health issues for Bandipora's Zalwan residents

BANDIPORA: Residents of the main town in north Kashmir's Bandipora district are facing distress as an ongoing fire at a dumping disposal site in the Zalwan area engulfs the vicinity in thick, acrid smoke

The locals said that they are grappling with health issues due to the relentless smog. Many locals report-

ed adverse health effects. "I had an uncontrollable coughing fit walking outside last night and nearly vomited from it," said Ishfaq Ahmad, a resident.

The noxious odour permeates even inside homes, forcing us to keep their windows tightly shut, he said, adding that several parts of the town remain shrouded in heavy fumes.

"We have no idea who is burning this garbage every day," lamented Mohammad Ashraf, another local resident

"People are experiencing eye irritation, sneezing, and discomfort, with some resorting to wearing masks even within the confines of their homes. Children, too, are not immune to the effects and have been complaining about eye irri-

tation," he added. The locals said that despite their persistent demands for the relocation of the dumping site, the authorities have not done anything.

Last year, the Pollution Control Committee identified that solid waste was being haphazardly and unscientifically dumped at the Zalwan Nassu site, dangerously close to the district headquarters of

The residents said that after a wait of around two decades, the hospital was shifted to a new building but it doesn't serve the purpose for which it was constructed.

"Even for minor surgery we are forced to visit District hospital Pulwama as theatre hasn't been made functional at SDH Pakherpora," they said.

Besides heavy snowbound areas like Abhama, Kanidajan and Yousmarg, the hospital caters to a huge chunk of the popula-

tion, they added. Sajad Ahmad, a local resident said that currently the hospital is function-

ing as SDH only on papers while the facilities are as

good as a PHC. He said that a gynaecologist was posted at the hospital but was transferred without any replacement.

Locals said that despite bringing these issues in notice of concerned authorities several times but no attention is being directed towards it.

"Whenever we have brought the issue of operation theatre in the issue of higher ups, we are being assured that the theatre will be functional within two weeks," they said.

An official of the health department said that they are on it and the theatre will be functional within the next three weeks.

20 years on, IG Road shopkeepers await rehabilitation: KTA

SRINAGAR: In a poignant reminder of unfulfilled promises, more than two decades have passed since over 300 shopkeepers along the historic IG road were displaced from their businesses, and to this day, they continue to await rehabilitation.

The Kashmir Traders Alliance (KTA) is now urging the Lieutenant Governor (LG) administration to intervene and provide justice to these affected businessmen who have endured years of hardship and uncertainty.

According to KTA, President Aijaz Shahdhar the saga dates back to December 2002 when the then government, led by Mufti Sayeed, ordered the demolition of all shops along IG road, citing concerns that their presence defaced the area and left an unfavourable impression on passing tourists.

"At that time, shopkeepers were given assurances by the Deputy Chief Minister, Muzaffar Baig, that they would be rehabilitated. They were instructed to submit their registrations to the Custodian General,

Bandipora and in proximity to the critical Wular Lake catchment area.

Meanwhile, an official told KNO that response teams have swiftly arrived at the scene to determine the cause of the fire. "Measures will be taken to perform earth filling to contain the fire, and comprehensive efforts will be made to ensure the fire is completely extinguished," he said—(KNO)
