ISRO To Flight Test Human Space Mission's Crew Module Escape System On Oct 21

will fly the first of the four Flight Test Vehicle Abort Mission-1 (TV-D1) to demonstrate the crew escape system on October 21 as part of its human space mission/ Gaganyaan, said a top official.

Speaking to reporters Indian Space Research Organisation (ISRO) Chairman S.Somanath said the first unmanned test mission TV-D1 will happen on Oct 21.

Somanath said there will be three more test flights TV-D2, TV-D3 and TV-D4 to test the systems.

"Preparations for the Flight Test Vehicle Abort Mission-1 (TV-D1), which demonstrates the performance of the Crew Escape System, are underway," ISRO had said recently.

The first development flight Test Vehicle (TV-D1) is in the final stages of preparation. The Test Vehicle is a single-stage liquid rocket developed for this abort mission.

The payloads consist of the Crew Module (CM) and Crew Escape Systems (CES) with their fast-acting solid motors, along with CM fairing (CMF) and Interface Adapters," ISRO said.

This flight will simulate the abort condition during the



ascent trajectory corresponding to a Mach number of 1.2 encountered in the Gaganyaan mission.

ISRO said the Crew Escape System with Crew Module will be separated from the Test Vehicle at an altitude of about 17 km.

"Subsequently, the abort sequence will be executed autonomously commencing with the separation of CES (Crew Escape System) and deployment of the series of parachutes, finally culminating in the safe touchdown of CM (Crew Module) in the sea, about 10 km from the coast of Sriharikota," ISRO said.

The Crew Module will house the astronauts in a pressurised earthlike atmospheric condition during the Gaganyaan mission.

For the Test Vehicle Abort Mission-1 (TV-D1), the Crew Module is an unpressurised version that to the launch complex.

According to ISRO, the Crew Module in this mission is extensively instrumented to capture the flight data for evaluation of the performance of various systems.

The Crew Module will be recovered after touchdown in the Bay of Bengal, using a dedicated vessel and diving team from the Indian Navv.

The Indian space agency said the Crew Module after integration underwent various electrical testing, at ISRO's facility in Bengaluru, including an acoustic test and was dispatched to the Satish Dhawan Space Centre in Sriharikota on 13th August.

At Sriharikota, it will undergo vibration tests and pre-integration with the Crew Escape System, before final integration to the Test Vehicle at the Launch Pad.

This Test Vehicle mission with this Crew Module is a significant milestone for the overall Gaganyaan programme as a nearcomplete system is integrated for a flight test. The success of this test flight will set the stage for the remaining qualification tests and unmanned missions, leading to the first Gaganyaan mission with Indian Astronauts, ISRO said.

Power Crisis

While he claimed that losses have mounted worth crores of Rupees, he said the production has gone down by 65 per cent since last one month.

"Even though we have limited hours of work, the industrial sector doesn't get the desired power supply. The situation is such that the production has gone down by 65 per cent, which means a big loss to the sector," he said.

The industries, which, as per Kamili are mostly hit include cold storage, apple grading and packaging industries and furniture

These are some of the industries, which require uninterrupted supply of electricity. The machines used in these industries are automatic, which require constant supply of electricity. Our members are constantly saying that these industries are suffering due to the non-availability of abundant electricity during peak hours," he said.

President Kashmir Chamber of Commerce and Industries (KCCI) Javaid Ahmad Tenga said they are getting SoS calls from various industrialists about the impact of the poor electricity supply.

"Handicraft artisans and dealers have Goals (SDGs) as we have only one earth. been constantly telling us about the suffering of the sector due to the current power crisis. The tourism sector has also started facing problems now. There is a massive drop in production by industries currently," he told KNO.

Tenga said the lack of proper electricity was leading to the cost escalation to the industries. "Everything currently works on generators which is leading to the cost escalation to the industrialists. We recently approached the government with the demand to ensure uninterrupted power supply but nothing has happened so far," he said.

The KCCI has demanded the establishment of a fact-finding committee to delve into the underlying factors responsible for the ongoing power crisis in Kashmir-

for bid preparation and submission. Following the pre-bid meeting and the public unveiling of technical bids, meticulous scrutiny by the Central Tender Committee affirmed that three out of four bidders, including IFFCO Tokio General Insurance Company, Bajaj Allianz General Insurance Company, and National Insurance Company, met the specified requirements, qualifying for the subsequent stage.

Opening financial bids revealed IFFCO Tokio General Insurance Company Ltd. as the lowest (L1) bidder with a quoted rate of Rs 1840/- per family.

With the imminent expiration of the policy with Bajaj Allianz GIC on December 25, 2021, SHA J&K sought an interim arrangement to prevent service disruption. Bajaj Allianz GIC responded by offering to continue implementing the scheme at a quoted price of Rs 3,261.60 per beneficiary family unit on a Pro-Rata basis for the requested coverage period.

To prevent service interruption, SHA J&K entered into an agreement with Bajaj Allianz GIC to continue services on a Stop Loss basis until the selection of a new Insurance Company is finalized. The Insurance Company would not share the risk of loss of claims, and the entire claims outgo would be borne by the Government of J&K and the National Health Authority

The financial details underscore that the Interim Arrangement, with 15% administrative charges, was the most cost-effective option, serving public interest during the transition period. Contrary to the misinformation circulating on social media, there were no changes or additions to the number of beneficiary families, which remained consistent throughout both the primary policy and the interim period.

Despite the necessity for retendering due to high premium rates quoted by the lowest bidder (L1), the interim arrangement with the existing insurance company continued seamlessly, benefiting over 69,000 individuals. This underscores the scheme's commitment to public interest. Contrary to misinformation, the interim arrangement was thoroughly vetted by the Law department, Finance Department, and Learned Advocate General, contradicting claims that the government ignored advice from

J&K Govt clarifies PMJAY-SEHAT Scheme implementation amidst misinformation

JAMMU: In a press conference held Saturday, the Secretary Health and Medical Education, Bhupinder Kumar has addressed concerns and allegations surrounding the implementation of the Pradhan Mantri Jan Arogya Yojana - SEHAT (PMJAY-SEHAT) scheme.

One of the key allegations was related to a loss of Rs. 500 Crores. The government clarified that the total premium paid to Bajaj Allianz General Insurance Company (BAGIC) during the policy period from December 26, 2020, to March 14, 2022, was Rs. 304.59 Crores, while the total claims payout to hospitals (both public and private) by BAGIC was Rs. 398.41 Crores. Consequently, the allegation of a loss is unsubstantiated as the insurance company incurred a monetary loss of Rs. 93.82 Crores.

Misinformation about the termination clause and contract renewal has also surfaced. According to the contract between BAGIC and the State Health Agency, the maximum term was fixed for three years and renewable every 12 months. The continuation of the contract beyond the first year was to be based on mutual agreement, and the insurance company decided to exit after the first year due to incurred losses

To avoid service interruption, the State Health Agency of J&K entered into an interim arrangement with BAGIC on a Stop Loss basis until a new insurance company was selected. During this period, the government bore the entire risk of loss of claims. The arrangement was cost-effective and served the public interest by ensuring the continuity

of healthcare services. Contrary to allegations that the number of eligible families was increased to benefit the insurance company, the government clarified that the number of families remained the same during the policy period, from December 26, 2020, to December 25, 2021, and the subsequent interim period of 79 days, totaling 21.24 lakhs.

The Government of Jammu and Kashmir emphasized its adherence to the guidelines of the National Health Authority (NHA), Government of India, for the scheme's implementation. This includes the use of the Model Tender Document for the transparent selection of insurance companies and the adoption of Health Benefits Packages (2.2 version) for implementation.

Since the launch of the PMJAY-SEHAT scheme, the government has paid Rs. 1175.32 Crores in premiums to insurance companies. In return, insurance companies disbursed a total of Rs. 1,249.33 Crores in claims to empaneled hospitals, benefiting approximately 5.67 lakh patients. The scheme has provided crucial medical care for patients with lifeconsuming and life-threat-

ening diseases The insurance model has shifted the risk to insurance companies, leading them to pay nearly Rs. 74 Crores beyond the premium to empaneled public and private hospitals. This model has strengthened the healthcare system within the UT and significantly reduced out-of-pocket expenses for families in need of hospitalization.

Additionally, a feedback system using QR codes and a 104 Call Centre has been implemented, with nearly 99% of patients rating their treatment experience as Excellent or Good.

The government emphasized that allegations intended to discredit the scheme are baseless, false, and aimed at maligning its image. It reiterated its commitment to providing quality healthcare services to the public.

Divisional Commissioner Jammu Ramesh Kumar, Additional Secretary in Chief Secretary office, Vishal Sharma, Joint Director HQ Information, Naresh Kumar, Deputy Director Information PR Jammu, Dr. Vikas Sharma were also present during the press conference.

The joint director also clarified that recording for foundational stage that is upto 2nd standard shall be made exclusively on Holistic Progress Card

(HPC) only. Earlier in September, JKCERT has said that the HPC developed by NCERT has been adopted by this

"Holistic Progress Card (HPC) encompasses not only the academic achievements of a student but also captures his/her socio-emotional growth, creativity, and vocational proficiency," reads the previous communique of JKSCERT.

It also said that the progress card proposes the use of integrative pedagogy in order to track the students performance.

Not that he was the first person to die due to suicide but this case is peculiar. This guy was from an upscale business family, had a great recurring monthly income, a thriving business, a lavish house in a posh colony of Srinagar, a dandy private school education, sports utility vehicles and all comforts of modern life at his disposal. Just a few family scuffles broke his morale and his desire to live further. A life lost and two small children without a father. We often ignore mental health issues as if they are not important. Mental health issues are as important as physical health issues. Both are inter-related. Here we have an example of a person who had every materialistic thing at his disposal but no mental peace. We impress upon the government to make mental health counseling accessible to a common man through multimedia sources. It is amazing that despite living in 2023 there still is a taboo attached in seeking mental health counsel openly. Society, for some strange reasons, looks down upon people who go to let us say a psychiatrist. This attitude has to change. There has to be rigorous messaging sent from multi-media sources which highlight the importance of mental health, in seeking help when in need, knowledge of guiding steps to prevent one's mental health being. The government can run counseling centres or dedicate a room or cabin at primary health centres to mental health counseling. The Humility Of The Scientists Who Took India To Moon Is Truly Remarkable



When Will We Start Caring For Our Caregivers?

Lancet Commission report investigating the nexus of "Women, power, and cancer" says that "patriarchy dominates cancer care, research, and policy making.

The report underlines that "women experience gender bias. and are subject to overlapping forms of discrimination, such as due to age, race, ethnicity, socio-economic status, sexual orientation, and gender identity." These intersecting factors "restrict a woman's rights and opportunities to avoid modifiable cancer risks and impede their ability to seek and obtain a prompt diagnosis and quality cancer care.

But cancer is not the only disease that afflicts women. They battle a plethora of illnesses and an equitable access to healthcare services eludes a vast majority of them. Women are often diagnosed, if at all, in more advanced stages of any disease. The long-time interval between the first presentation of symptoms- be it a communicable disease (like TB, HIV, etc) or non-communicable disease (like diabetes, hypertension, cardiovascular disease) and final diagnoses not only makes recovery more difficult but also puts them under tremendous physical, mental and economic stress

The report authors concede that "Globally, women's health continues to be focused on reproductive and maternal health, a patriarchal construct that is aligned with narrow anti-feminist definitions of women's value and roles in society.

All of us want to remain healthy. Then why is it that women often seek healthcare services very late, (or not seek them at all) as compared to men? And adding fuel to fire is that more often than not, we unconsciously put the blame on the woman for being careless regarding her health and for delaying seeking medical advice.

This is akin to blaming the victim for her deplorable situation (and poor health seeking behaviour) rather than focussing on the perpetratorskewed social norms and gender roles arising out of patriarchy and toxic masculinity.

Why are caregivers not care seek-

The primary role of a woman is taken to be that of a caregiver, and not a care seeker. And this is not due to the presence or absence of any gene. Granted that women and men are biologically different, is there any gene that prevents men from doing household chores and childrearing, or is there any gene that puts the onus of these on women alone? Surely not. It is not any genetic construct, but a social construct that arises from the deep-rooted patriarchy that seeps deep in every nook and corner of a woman's life and manifests itself in myriad ways due to which she suffers exploitation and discrimination at every stage of her life. These are not genetic problems but are due to gender inequality. They are due to the distorted patriarchy that is present in families and manifests itself in several ways

Caregiving has been feminised and women have been moulded into nurturing roles which often go unrecognised by their family members, as well as by healthcare systems. It is mostly girls and women who are primary caregivers for the family. They are expected to prioritise the needs of the other family members- from an infant to the oldest member- at the expense of their own health, and this often results in women's postponement of seeking healthcare for themselves.

It is not uncommon for the females of the family to keep on doing house-



hold chores despite being sick. Any early symptoms of any illness are brushed aside by all. They ignore their health problems, and the menfolk also do not pay any attention, until they become so sick that they are unable to manage the house and family. It is only when she is bedridden that the gravity of the situation hits everyone. Very often I have heard this remark from my female acquaincare and domestic work is performed by women and girls, which is more than three times than that done by men. Also, two-thirds of care workers

Gender roles arising out of patriarchal social norms are often very different for men and women, and lead to gender inequalities, including limiting access to healthcare. Idolising 'homemaker' and 'motherhood'

(the leading cause of which is dietary iron deficiency) than men. According to a study conducted by the Institute for Health Metrics and Evaluation (IHME) and published in The Lancet Hematology, 444 million men and 825 million women were diagnosed with anaemia in 2021.

"Gender inequalities related to household food consumption and division of labour probably exacer-

need to be responsible towards our health and wellbeing. Women will have increased awareness of cancers and other diseases that they deal with, either directly or indirectly, only when they become more conscious about their mental and physical health and health seeking behaviour. But for this, they have to free themselves from the poisonous patriarchal setup, and men have to free themselves from toxic masculinity. Most often men fail to see these ills of society. They do not even realise the special entitlements and privileges they enjoy by virtue of being born a male, while women are deprived of them just because of being born a female (and not because

of any genetic defect). Is there any man who has not reaped the benefits of gender inequality? Is there any woman who has not suffered this inequality at some point of her life?

Every humanitarian or health response has to be a feminist response. We need feminist systems. That does not mean putting the current development model in the hands of women. It means having a different kind of system that is based on sharing and caring. The opposite of patriarchy is not matriarchy- it is feminism. Patriarchy is about using power and violence against other people in order to gain power. Feminism is about using care and solidarity to redistribute and share power.

A feminist health system is one that is socially just and ecologically sustainable for everyone everywhere. It recognizes the power of communities when they take ownership of their well-being. A people centric feminist approach to improve health seeking behaviour as well as access to disease prevention, treatment and care is key.

I firmly believe that a world of solidarity can only be a feminist world where everyone - irrespective of their caste, creed or sexual orientationcan have a dignified, respectful and healthy existence.

It is the 'gene' of patriarchy that manifests in poor health seeking behaviour of women and prevents them from seeking timely diagnosis and treatment. It is this very 'gene' that permits menfolk to escape the chores of child rearing and become equal partners in running the household. And I quote from the report: "Since gender norms often exclude men from participating in childcare in many settings, covering these caretaking roles can act as a barrier for women to seek care for their own health needs.'

Unpaid care work has a direct bearing on the wellbeing of an individual. It includes, among other chores, the time spent in cooking, looking after children, and taking care of those who are ill. Globally, women and girls perform more than 75% of all unpaid

role, gives '(un)graceful escape' to men from child-rearing and household chores, putting their onus on women. All this acts as a barrier for women to seek care for their own health needs.

Even when a woman recognises the need to seek healthcare, gender norms often restrict her choice of when and where to seek or access care. She is faced with inequities in treatment, care and access to healthcare, due to social discrimination that prioritises the health needs of men, as the latter are considered to be more valuable.

So, while women are acknowledged as the primary caregivers in families, little attention is paid to their own health and well-being. In many countries of South Asia, including parts of India, it is not uncommon for women to eat after the menfolk have eaten, and men are prioritised over women (and even children) if there is limited nutritious food available in the household. It is no wonder then that women are far more likely to suffer from anaemia

bate disparities in conditions such as anaemia, because women might be the most likely among household members to be affected by food insecurity, and to lack access to sufficient quantities of iron-rich foods, and be less likely to receive health screening and care, whether due to domestic work demands, lack of autonomy, or prioritisation of other family members' care." said the study authors.

Citing data from the National Family Health Survey 2019-2021, the "Women and Men in India 2022" report released by the Ministry of Statistics and Programme Implementation in 2023 shows that prevalence of anaemia in women aged 15-49 years has increased by 4%- from 53% in 2015-16 to 57% in 2019-2021. This is yet another worrisome trend of women's health. Anaemia is an indicator of both poor nutrition and poor health, and failure to reduce it can result in impaired health and quality of life for millions of women, including adverse health outcomes in chil-

dren born to anaemic mothers. All of us- women and men alike-

Div Com calls for early notification of PDA's **Master Plan under revision**

JAMMU: Divisional Com missioner Jammu, Ramesh Kumar, on Saturday chaired a significant meeting to oversee the progress on the revision of master plan of the Patnitop Development Authority (PDA) and related issues.

G20 under India's presidency gave hope that multilateral institutions can deliver: Sitharaman

NEW DELHI: Finance Minister Nirmala Sitharaman on Friday had an interaction with Josh Lipsky of Atlantic Council wherein she spoke about India's economic outlook and the country's goals as G20 president, following the 4th G20 finance ministers and Central banks governors (FMCBG) meeting held on October 12-13 and IMF-World Bank meetings in Marrakech, Morocco

The Finance Minister expressed happiness over the fact that under India's presidency, G20 has given the world a glimmer of hope, especially at a time when one thinks that multilateral institutions can't



take any decisions and deliver.

"During our G20 presidency, a sense of wanting to deliver was on our minds. So it's not just to the credit of the Indian G20 Presidency but the members who felt that this was the best opportunity to come out, showing the world that we can take decisions," the Finance Minister said

Speaking about payments infrastructure for emerging economies, Sitharaman said that for countries. particularly those in Africa and some of the island countries in the Pacific, there's a serious problem of not having enough dollars to pay for what they essentially need and we have seen this lasting for more than a desirable time.

"So, in those circumstances, we have said that they can pay in their local currencies, provided that India and those countries establish some kind of equation. Equally, we are talking to countries to develop digital payment systems compatible with one another for efficient and real-time transfer," she said during the interaction.

Technology is being readily adopted by Indian citizens of different backgrounds because of the use of regional languages. Many services do not require smartphones, they can be used on feature phones as well, the finance minister added.

"This use of technology isn't confined to payments. We even issued vaccine certificates on phones. Anyone travelling abroad had it on their phones. It showed when they took the vaccine, when is the next date due and where can they take it," she informed.

People From Gaza Should Evacuate Between 10 A.m To 4 P.m: IDF

JERUSALEM: The Israeli military has asked people from northern Gaza to evacuate southwards using two routes between 10 a.m. in the morning to 4 p.m. in the evening, a spokesman said on Saturday.

In a statement posted in Arabic on X, Israel Defense Forces (IDF) spokesman Avichay Adraee said the routes can be used between the said period of time "without any harm", reports CNN.

Those living in Gaza City have been advised to move south from Beit Hanoun to Khan Yunis, ahead of a potential ground offensive by the Israeli army, Adraee said.

People living near the beach and west of Olive will also be allowed to move on Daldul and Al-Sana Streets towards Salah Al-Din and Al-Bahr, he added. On Friday, the IDF had

all civilians of Gaza City from

their homes southwards for

tion and move to the area south of the Wadi Gaza".

Wadi Gaza, known for its coastal wetlands and biodiversity, is a river valley located around the centre of the Gaza Strip, snaking across its entire width and ending in the Mediterranean Sea.

'You will be able to return to Gaza City only when another announcement permitting it is made," the military had said, adding that the Hamas militants were hiding inside tunnels underneath the ciy and inside buildings populated with civilians.

It urged civilians to evacuate the city "for your own safety and the safety of your families and distance yourself from Hamas terrorists who are using you as human

"In the following days, the IDF will continue to operate significantly in Gaza City and make extensive efforts to avoid harming civilians.'

'To imagine that you could move one million people in 24 hours in a situation like Gaza can only be a humanitarian crisis," Borrell said.

Despite the EU's expression of support for Israel, he also warned that it was also obligated to follow international humanitarian law in the process of defending itself.

"The position is clear. But, as any right, it has a limit. And this limit is international law."

Also on Friday, UN aid chief Martin Griffiths had said that "order to evacuate 1.1 million people from northern Gaza defies the rules of war and basic humanity", CNN reported.

"Gaza is under intense bombardment. Roads and homes have been reduced to rubble. There is nowhere safe to go," Griffiths said on X, formerly Twitter.

"Forcing scared and traumatized civilians, including women and children, to move from one densely populated area to another, without even a pause in the fighting and without humanitarian support, is dangerous and outrageous."

He reiterated that "without safe passage and access to basic services, such mass displacement of civilians will have catastrophic humanitarian consequences and longterm implications"

At least 1,900 Palestinians have been killed by nearconstant shelling in Gaza, according to the Health Ministry, including journalists and medics.

Trump Trolled By Media For Comments On Israel-**Hamas Conflict**

In a post on his Truth Social social media platform, the former President wrote: "I have always been impressed by the skill and determination of the Israeli Defense Forces. As they defend their Nation against ruthless terrorists, I want to wish every soldier the best of luck. May you return home safely to your families, and

Rolling Stone magazine was the first to report that Trump has privately been calling for Prime Minister Netanyahu to be "impeached" for failing to anticipate the brutal Hamas attack on October 7.

may God bless you all!

As the Rolling Stone report rolled on, Trump was already under heavy fire from Israel, President Joe Biden and even Republican rivals over comments he made at a campaign rally on Wednesday, criticising Jerusalem over the intelligence failure that led to the Hamas assault, calling Defence Minister Yoav Gallant a "jerk" and the Hezbollah terror group "very smart", ABC News reported.

Trump laid it on thick by saying Netanyahu did not do enough to assist the US in the latter's 2020 killing of Quds force Chief Qassem Soleimani.

His campaign later issued an additional statement listing all of the steps Trump took as President to support Israel. On Friday, Trump

spokesman Steven Cheung said the Rolling Stone report was "100 per cent untrue" and "never happened".

"These unnamed 'sources' are simply making this up out of thin air. This is the most egregious example of Fake

News," Cheung wrote on X. Meanwhile, the Guardian newspaper said that the White House in a rare move on Thursday publicly pushed back against Trump

Trump in a campaign speech in Florida referred to Hezbollah, based out of Lebanon to the north of Israel and the Pentagon's deep concern about the militants attacking Israel from the nort, opening up

after his remarks on the Israeli Defence Minister and

the Hezbollah.

"Two nights ago I read all of Biden's security people ... they said, 'Gee, I hope Hezbollah doesn't attack from the north, because that's the most vulnerable spot'. I said, 'Wait a minute. You know, Hezbollah is very smart'. They're all very smart," Trump said, going on to add that "the press doesn't like when" he says things like that, as he has when praising the effectiveness of China's President Xi

Trump swiped at two top Israeli officials, Defence Minister Gallant and Prime Minister Netanyahu, with whom Trump once appeared to be close.

"They (Israel) have a national defence minister ... if you listen to this jerk, you would attack from the north because he said that's our weak spot," Trump said.

Gallant's office reportedly said in response that Trump was making "farfetched speculation" and attested to the military's

Of Netanyahu, Trump said he "let us down" while talking about the US killing of Soleimani.

Biden spokesman Andrew Bates said in a Thursday statement that what Trump said about Hezbollah was "dangerous and unhinged"

"It's completely lost on us why any American would ever praise an Iran-backed terrorist organization as 'smart'... This is a time for all of us to stand shoulder to shoulder with Israel against 'unadulterated evil'," Bates said.

Trump's comments also drew criticism from his former Vice President Mike Pence, who is challenging him for the 2024 Republican presidential nomination.

"Hezbollah aren't smart. They're evil," Pence said during a New Hampshire radio appearance on Thursday

Trump, the frontrunner for the nomination so far, is "simply not expressing -- and his imitators in this primary are not expressing -- the same muscular American foreign policy that we lived out every day", Pence said.(IANS)

S. Korean Military Jet To Bring 163 Nationals Home From Israel



SEOUL: A South Korean military aircraft was bringing 163 nationals home from Israel, along with some 60 foreigners on Saturday amid the raging conflict between the Jewish nation and the Hamas militant group, the Foreign Ministry here said.

A KC-330 military transport plane carrying the South Koreans departed from Tel Aviv early Saturday and is expected to land at Seoul Air Base in Seongnam, just south of Seoul, later at night, Yonhap News Agency quoted the Ministry as saying.

The plane is also bringing 51 Japanese and six Singapor-

ean nationals, as part of Seoul's efforts to provide humanitarian cooperation, it added.

The plane left for Israel the previous day.

It marks the first such transportation of South Koreans by a military plane and the second flight to bring citizens home from Israel following the return of 192 people aboard a Korean Air plane on Wednesday.

The government decided to dispatch the military plane as air carriers increasingly suspended flight operations to and from Ben Gurion International Airport on the outskirts of Tel Aviv amid the intensifying conflict, officials

Of the 163 people on board, 82 were short-term travellers, while the rest were residents.

About 470 South Koreans remain in Israel.

Most of them are residents living there long-term and have chosen to stay behind of their own accord, a Foreign Ministry official said, adding the diplomatic mission there continues to advise them to leave the area for safety.

Roughly 630 South Koreans had been staying in Israel before the military plane took the people

Security Heightened In US Cities **Amid Protests, Mounting Tensions**

WASHINGTON: As the Israel and Hamas conflict has continued to rage for a week now, protests were erupting and tensions are mounting across the US, prompting an enhancement in security.

Major American cities, including New York, Washington, D.C., Los Angeles, Portland and Pittsburgh, are on a heightened alert in bracing for protests and potential violence this coming weekend, reports Xinhua news agency.

Hundreds of people joined a rally at the Times Square in Manhattan on Friday afternoon, chanting and waving the Palestine's red, black and green flag.

Some held signs reading "Free Palestine" and demanded ending the bombardment of Gaza and the funding of Israeli military.

On Thursday evening, two groups of students gathered in dueling rallies at the Columbia University in New York, in support of either Israel or Palestine in the wake of the Gaza conflict. Tensions also heated as pro-

Palestine and pro-Israel groups

clashed on campus at The Univer-

sity of North Carolina at Chapel

The scene turned hostile and chaotic as the two sides shouted and argued back and forth with physical confrontations in some cases, according to a report of the WRAL News.

The demonstrations came after former Hamas leader Khaled Mashal called for Friday to be a global day of protests against Israel's retaliation against Hamas, and urged supporters to send a "message of rage to Zionists and to America".

Law enforcement agencies across the UShave stepped up their presence around synagogues, places of worship in the American Jewish community, and Israeli diplomatic posts.

During a press conference Thursday evening, New York City Mayor Eric Adams and New York Governor Kathy Hochul stressed that the safety of New Yorkers is of the utmost concern.

"We have directed the NYPD (New York City Police Department) to surge additional resources to schools, houses of worship, to ensure they are safe and that our city remains a place of peace,' Adams said.

NYPD canceled all training for

officers Thursday and ordered the force to be in uniform and on

patrol, NBC News reported. In Washington, D.C., police said that there were no credible threats to the area, but they were expecting increased law enforcement visibility to help ensure the safety of the community.

Police also enhanced security in the Capitol complex.

Meanwhile, Florida Governor Ron DeSantis has declared a state of emergency to enhance security around pro-Israeli and pro-Palestinian demonstrations, including on campuses.

In most major Texas cities, including Austin, Dallas and Houston, police issued advisories about increased vigilance or patrols in response to the call for Friday demonstrations.

According to the Center on Extremism at the Anti-Defamation League, at least 140 protests across the country have been tracked since the Hamas attack on Israel on october 7, in which some protesters glorified violence and attacks on civilians.

Online threats against Jewish people have increased 400 per cent since the conflict erupted, the group said.

Union Workers Reach Tentative Deal After Largest Healthcare Strike In US

WASHINGTON: Kaiser Permanente, the largest healthcare nonprofit organization in the US, has reached a tentative deal with the unions representing over 75,000 employees, after the largest healthcare workers' strike on record in the country.

'The frontline healthcare workers of the Coalition of Kaiser Permanente Unions are excited to have reached a tentative agreement with Kaiser Permanente." union officials said on X on Friday.

Kaiser Permanente also posted a similar announcement on the platform.

Both sides expressed their gratitude to the instrumental involvement of Acting US Labor Secretary Julie Su.

More than 75,000 workers with the Californiabased healthcare provider went on strike for three days last week, demanding better pay and benefits. Union officials had

warned that the three-day strike "will be the initial demonstration of our strength to Kaiser" and "another longer and stronger" strike would be staged next month if a new contract agreement couldn't be reached by then.

Kaiser admitted staff shortages in a statement, saying it's a problem that every healthcare provider in the nation has been facing.

staff shortages in the US healthcare industry, which was exacerbated by the pandemic. This year saw a record of labor activities in the

US, as the number of workers involved in strikes has reached at least 411,000, the highest since 2019, recent data showed. This year's strikes also

lasted longer than those in recent history, according to data from the Bureau of Labor Statistics and Cornell University's Labor Action Tracker.

Workers have walked out from various industries such as healthcare, entertainment, automobile, hotel and airlines.

Negotiations between Hollywood studios and the US entertainment industry's largest union representing 160,000 actors and performers were suspended on Wednesday night after the two sides failed to reach a deal.

Hollywood has shuddered to standstill since the start of the Screen Actors Guild-American Federation of Television and Radio Artists (SAG-AFTRA) strike in mid-July.

In another high-profile strike, more than 34,000 auto workers from the "Big Three" automakers --Ford, General Motors and Stellantis -- are on strike, which has lasted nearly one month.

2 Men Charged For False **Bomb Threat In Singapore**

SINGAPORE: A 30-year-old Australian man and a 39-yearold man were charged with false bomb threats in two separate cases on Saturday, according to a statement by the Singapore Police Force.

During a Scoot flight to Perth, Australia, on Thursday, the 30-year-old passenger informed cabin crew members repeatedly that he had a bomb. As a result of the threat, the plane had to turn back to Singapore, the statement noted.

The man may be liable to an imprisonment term of up to 10 years, a fine up to 500,000 Singapore dollars (about 365,000 U.S. dollars), or

both, for making false threats of terrorist acts, according to the statement. In another case on Friday, the

Tiriya Encounter: NIA **Files Chargesheet Against 12 People**



DELHI: The National Investigation Agency (NIA) has filed a chargesheet against 12 individuals in connection with the 2019 CPI (Maoist) attack on security forces. in which six Maoists and one civilian were killed near Tiriya village in Chhattisgarh, an official said on Saturday.

The accused have been slapped with charges under various sections of the Indian Penal Code (IPC), the Arms Act, and the Unlawful Activities (Prevention) Act (UA (P) Act) in the charge sheet which was filed on Friday.

In a statement issued by NIA on Saturday, it said that the investigation unveiled a sinister plot by a group of Maoist cadres, led by senior figures including Sanju, Lxman Nag, Dashri Kawasi, Dubasi Shankar, Jalimuri Srinu Babu, Vijayalaxmi, Ramesh Kunjami, and others, who conspired to execute this

violent act. The assailants, armed with sophisticated weaponry, targeted combined teams from the District Reserve Guard (DRG), Special Task Force (STF), State Police,

and the Central Reserve Police Force (CRPF) that were engaged in a search operation near Tiriya Village in Jagdalpur.

"In addition to the primary suspects, further individuals linked to the case have been identified. including B. Ch. Padma, Dubasi Devender, Dongari Devendra, Duddu Prabhakar, and Kandula Sirisha. These accused were clandestinely associated with various organisations while actively supporting the CPI (Maoist)," it said.

"These accused maintained close ties with the top leadership of the CPI (Maoist) and played pivotal roles in furthering the unlawful and violent agenda of the banned organisation. received funding from the CPI (Maoist) to facilitate their operations and used various front organisations to disseminate Maoist ideology," read the NIA statement.

The case was originally registered on June 28, 2019, encompassing various sections of the Indian Penal Code (IPC), the Arms Act,

and the UAPA Act. Subsequently, on March 18, 2021, the NIA assumed control of the case.

NEW DELHI: The G20 Parliamentary Speakers in a joint statement issued at the conclusion of the P20 summit on Saturday, reaffirmed their commitment to continue to engage in parliamentary diplomacy and dialogue in relevant for as a catalyst for promoting international peace, prosperity and harmony, including supporting peaceful resolution of conflicts and disputes.

The P20 Parliamentarians also underscored the urgency for disaster risk reduction in the face of natural disasters and other emergencies, sometimes with magnitudes beyond the response capacity of affected countries

'We affirm that international cooperation among countries at all levels, including Parliaments as well as public and private and philanthropic organisations, is essential to mobilise flexible and sustainable resources, for preparedness and disaster risk reduction, for anticipatory and early action, for rapid response and early recoverv activities, as well as for building community-level resilience," the joint statement said.

The Parliamentarians also condemned terrorism

in all its forms and maniour legislative, budgetary festations, including those and oversight functions, we on the basis of xenophobia, pledge to play our role in racism and other forms of combating terrorism and violent extremism," the statement elaborated. intolerance, or in the name of religion or belief, recognising the commitment of

The statement noted with concern that globally women remain significantly under-represented in national Parliaments.

In this context, we welcome the adoption of the Women's Reservation Bill, 2023 by the Parliament of India in September 2023.

It also welcomed the African Union as a permanent member of the G20 and strongly believed that inclusion of the African Union into the G20 will significantly contribute to addressing the global challenges of present times.

"In this context, in the framework of P20, we will develop close parliamentary ties with the Pan-African Parliament," the statement added.

Staff shortages, lack of vital facilities plague GMC B'la-associated hospital

SRINAGAR: The Government Medical College (GMC) associated hospital in Baramulla is grappling with a severe shortage of staff, along with the unavailability of essential MRI and Cath Lab facilities.

Official sources revealed that around 100 positions are vacant at GMC-associated Baramulla, significantly hindering the hospital's day-today operations.

They said that out of the 228 sanctioned positions, only 131 are currently occupied, leaving 97 posts across gazetted, non-gazetted, and Class IV categories unoccupied. Among these vacancies, there are 23 gazetted posts, 62 non-gazetted posts, and

is adversely affecting the hospital's ability to maintain daily operations, causing inconvenience for both patients and healthcare providers.



Notably, hundreds of patients at the Government Medical College Baramulla are left without a cath laboratory, a specialised area where minimally invasive tests and advanced cardiac procedures are performed to diagnose and treat cardiovascular diseases.

According to officials, the cardiology unit is operational at of patients with minor or major heart issues to hospitals in Srinagar.

According to the Centres for Disease Control and Prevention (CDC), nearly 47% of deaths occur due to sudden cardiac arrests before an individual reaches the hospital.

The critical "golden hour" following a heart attack, within which timely intervention can save a patient's life, is compromised. The absence of a cath lab significantly impacts the ability to perduring this crucial time.

In the absence of a cath lab, patients lose precious time travelling to hospitals in Srinagar. Doctors

stressed that establishing a cath lab at the hospital could potentially save the lives of numerous patients who currently lose valuable time in transit.

Additionally, patients in north Kashmir face hardships due to the unavailability of Magnetic Resonance Imaging (MRI) facilities at Government Medical College Baramulla. They are forced to visit private diagnostic centres, incurring substantial costs for MRI scans.

Patients in Baramulla are facing undue hardships due to the lack of MRI facilities at GMC Baramulla, compelling them to resort to expensive private diagnostic centres

Suhail Ahmad, a resident of Baramulla, shared his ordeal, stating that the hospital, he had no choice but to visit a private diagnostic centre. He revealed that undergoing an MRI at these private facilities costs approximately Rs 5000-6000, putting a financial strain on patients already burdened by medical expenses.

Residents from north Kashmir highlighted the scarcity of MRI facilities in government hospitals. despite the presence of around 700 health facili-

ties across three districts. They have urged the authorities to address the staff shortages, equip the hospital with Cath Lab, MRI, and other vital facilities, and expedite infrastructure development to improve healthcare access.

Principal GMC Baramulla, Dr Ruby Reshi, told KNO that they have raised the issue of vacancies with the relevant authorities and remain hopeful that these positions will be filled establishment of both MRI and Cath Lab facilities, as all construction work has been halted for the past several months—(KNO)

7 years on, authorities yet to make power receiving station functional in Pulwama

PULWAMA: After more than seven years, authorities are vet to make the power receiving station functional in Charipora village of Pulwama.

Locals said that a receiving station was sanctioned for the Charipora area on the Pulwama-Budgam boundary in 2016. They said if made functional, it will cater dozens of Pulwama and Budgam villages.
