SRINAGAR: The low visibility amidst the foggy weather conditions have delayed three flights at Srinagar International Airport on Tuesday morning while the minimum temperature has continued to go dip further with most of the places recording coldest night of the season.

As per the Meteoro-

logical department, the shallow to moderate fog would likely continue till November 27.

However, the foggy weather conditions have led to the low visibility in morning and evening hours across Kashmir, thus simultaneously delaying three morning flights at Srinagar International Airport today.

Director Airport, Javed Anjum said that three flights have been delayed this morning due to the foggy weather conditions. 'However, as the visibility improved later in the afternoon, the flight operation was resumed. Only three flights got delayed, Anjum said.

'Smog formed due to temperature inversion'

SRINAGAR: Temperature inversion is leading to formation of smog in Kashmir in the last few days, PCB scientist said on Tuesday.

Senior PCB scientist Dr Bilquees Ara said that temperature inversion, that is the deviation from typical meteorological phenomenon, leads to the formation of smog.

The standard rule of meteorology is that air gets cooler with an increase in altitude. But temperature inversions change it. As a result, you will see weather phenomena like fog, smog, mist, and hazy horizons. Generally, it's more common in mountain-

ous regions or valleys or during winter when a cold night breeze from the mountains swoops to the ground," she said. According to

her, temperature

inversion usually

happens during O the night when the ground temperature drops because it's no longer heated by the sun.

"As cold air close to the ground gets trapped by the layer of warm air due to which air becomes stagnant and pollution becomes trapped close to the ground due to which people are exposed to this pollution and this inversion process often leads to the formation of smog," she said. 'Smog is the

formation of smoke, fog and sulphur dioxide which is emitted by different sources," she said, adding that sulphur dioxide is a pollutant and sulphates are detrimental to human health besides damaging plantations

and creating other problems. Dr Bilquees said photochemical smog is a type of smog produced when UV light originating from the sun interacts • P-06

Power Crisis

Demand For Solar Products Goes Up In Kashmir

SRINAGAR: Demand for solar panels and inverters has soared in Kashmir, which is currently reeling with a lack of adequate electricity supply. Kashmir, for more than

a month, is witnessing a severe power crisis, which has hit both domestic as well as commercial consumers As such the demand for

alternative sources, which include solar panel-driven inverters, has shot up by more than 40 percent. Imtiyaz Ahmad Khan,

a dealer of inverters and solar panel brand said that the demand for these alternative power sources has gone up for the last two months

"This year power crisis has escalated, which has forced people to buy and use alternative sources of electricity. We have wit-



nessed a good demand for the last two months and on an average daily we sell more than 60 solar paneldriven invertors" he said.

Khan said that various types of solar panels are available in the market, which help people to get a smooth flow of electricity during peak hours.

"There are monocrystalline solar panels available in the market, which use solar energy even during

cloudy or foggy weather. The demand for this particular solar panel is very much," he said.

Another deal Basharat Ahmad Sofi said other solar energy-driven equipment including solar water heaters and cookers are in good demand in Kashmir.

The aggrieved residents told Good Morning Kashmir that KPDCL is resorting to power cuts in the areas where smart meters have been installed.


Sulaiman Shah, a resident of Lal Bazar, said that for the past many days, they are facing unscheduled power cuts

SRINAGAR: Residents of Kalaal Doori locality of Naid Kadal here on Tuesday staged a protest over water scarcity in their area.

"For last six months, we are not getting adequate water supply. We have been given assurances by authorities, but nothing has been done in this regard," the protesting women said.

They said that at a time when the administration is claiming to provide drinking water to each household, we have been deprived of the same for the last six months.

"We have been visiting the offices of Jal Shakti officials and the district administration, but the authorities are turning a deaf ear to our repeated pleas," they said.



They blamed the authorities for neglecting their repeated pleas. "We have been facing severe water shortage even as we informed the authorities several times, but to no avail," they said.

They appealed Deputy Commissioner Srinagar and officials of the concerned department to look into the matter and redress their genuine demand at the earliest.

GANDERBAL: Residents in Ganderbal said they are "tired of complaining about the difficulties" they face while commuting on roads and walking on footpaths across the markets in the district

While police have taken some measures to clear up space on roads by challenging or seizing vehicles from no-parking zones, Municipal Committee Ganderbal seems least bothered about clearing footpaths of encroachments

in the town, locals said. Although the MC Ganderbal has launched several drives to clear encroachments from footpaths in some areas, it has failed to curb the menace perma-

nently, they added. As a result of the town's failure to maintain a close vigil over footpath encroachment, many shopkeepers and vendors continue to operate their businesses on the sidewalks, leaving no



"All of the Beehama and Duderhama market's alleyways have sidewalks that have been encroached upon," a group of commut-

ers told KNO. Despite repeated efforts by police to improve traffic management; the jams persist, especially in the evenings, they said, adding that this is because vendors, shop owners and other commercial establishments

Don't de-club the clubbed schools on your own: Authorities to CEOs

SRINAGAR: Authorities on Tuesday asked Chief Education Officers of (CEOs) of Jammu and Kashmir not to de-club the clubbed schools by their

Samagra Shiksha J&K, Deep Raj in a communique said this while issuing the instructions for de-clubbing the clubbed institutions in the respective districts of the CEOs as per the feasibility and norms governing the field.

"It is to mention here that the Chief Education officers of some of the districts of UT have been requesting this office to grant them permission for de-clubbing the clubbed institutions shown in UDISE+ 2023-24 in their respective area of their



jurisdictions," Raj said. The Project Director also said that the clubbing of the schools has been done as per the lists furnished by their offices after

seeking necessary approv-

al from the Administrative Department. "All the Chief Education Officers are therefore enjoined upon not to make any de-clubbing of the

clubbed schools at their

own level which may invite action against such default-

ing officers," it reads. The communique however said that in any such request of extreme exigency with full justification and background thereof may kindly be routed through Director School Education Jammu and Kashmir, so, that same is placed before Administrative Department for a decision on the matter as per merit of the case.

In the previous year, the School Education Department has said that it will merge nearly 800 government schools with low student enrollment.

It has also said that the merging of such schools is to be done in the backdrop of the disproportionate Teacher Pupil Ratio (TPR).

The government had also said that the students of those schools that will be merged and will fall out of the catchment area would be given transportation charges of Rs 500 each

month. Pertinently, the School Education Department in the previous fiscal has said that it had identified more than 1200 such government schools that were having low enrollment of students—(KNO)

Shopian's Daramdora village faces prolonged water shortage 'for years'

SHOPIAN: Residents of Daramdora village in Keegam hamlet of south Kashmir's Shopian district are grappling with a severe shortage of potable water that has persisted for "several years".

According to locals, the water supply scheme for the area was established in the 1980s to serve approximately five villages. "However, the population has expanded nearly four times since its inception, but the infrastructure has not improved," they said.

Daramdora village, in particular, has been facing a prolonged water crisis, with no significant improvements to date, they

Abbas Ahmad, a resident, said the existing pipeline is in a deteriorated condition and is no longer capable of meeting the demands of the connected households. While some residences received water for a period, newer houses constructed in the last ten years are yet to be included in the supply network, he said.

Aijaz Ahmad, another local, expressed frustration over the decade-long



wait for water supply. "Due to the absence of potable water, we are compelled to fetch drinking from a nearby canal, which has led to illnesses, particularly among the elderly and children," he said.

Residents criticised authorities for risking their lives by not addressing the issue. They further said that there is no drinking water supply facility available for a school where around 200 students are enrolled.

Despite bringing the matter to the attention of higher authorities on numerous occasions, no tangible action was taken. they alleged

An official from the Jal Shakti Department said that the area is now included in the Jal Jeevan Mission. "The work on a scheme costing approximately Rs 3.5 crore is going on," he said, adding that the water supply would be restored soon—(KNO)

Labour dept in action, rescues 8 juveniles in two days from Sgr parts

SRINAGAR: In a swift operation, the labour department has swung into action to curb child labour by rescuing at least eight juveniles in two days from Srinagar parts.

An official from the labour department said that the child rescue drive was planned by the department in Lal Chowk and adjacent areas of Srinagar in order to check for child labour in Srinagar City and to inform the people about child labour.

Assistant Labour Commissioner Srinagar, Arshid Qadir said that a team of labour department officials raided various shops in Lal Chowk in the past two days and found the two juveniles working at Shakti Sweet Shop Srinagar. "The officials immediately rescued the juveniles and asked the shop owner to submit age proof within two days, failing which they would face legal consequences,"

Qadir said that a total of

eight children have been rescued since yesterday (Monday).

About age proof of child labours, Qadir said that as per the honourable Supreme Court, an Aadhar Card is not a valid age proof and that a school certificate or a medical report will be considered as valid age proof.

"The child labour needs to be properly checked whether the individual is working with family on his own, or with someone else. The drive will continue till December,' Qadir said, adding that they are focusing on the drive in concentrated areas. He sought people's cooperation in curbing the child labour menace in Srinagar.

Asked about beggars in Srinagar, Qadir said that they first have to investigate the matter. "There is a need for ar full-fledged team from the Labour department and anti-trafficking unit to nail the child begging nexus. We are working on a plan to check the child-begin menace also," he said—(KNO)

Decline In Community Integrity In Modern Times



ot just a Portuguese connection, Goa also has a Paris link now. The "Global Call to find all TB to stop TB" which was launched earlier this month in Goa, India was in the prime spotlight at the World Conference on Lung Health 2023 in Paris.

The Paris conference reverberated with the loud and clear call: "We must find all TB to end TB" given by Dr. Guy Marks, President of the International Union Against Tuberculosis and Lung Disease -The Union. This was followed by the unambiguous statement: "The best treatments in the world will not be useful if we cannot find the people who need them," of Dr Nina Russell, Bill and Melina Gates Foundation.

Find all TB to stop TB

Earlier this month in Goa, a multistakeholder conference on the theme "Find All TB to Stop TB" opened with recommendations from a consultative conference held right after the United Nations High-Level Meeting on TB in Virudhunagar, Tamil Nadu, India, and hosted by Rainbow TB Forum and Blossom Trust. One of the recommendations was: "India has efficient TB testing methods (such as, WHO recommended laboratory-independent, point-ofcare and de-centralized molecular test), but we need to make sure that everyone has access to them as per the World Health Organization (WHO) guidelines." The first action point that emerged from this conference was: "We need to ensure that TB tests that underperform- like smear microscopyare replaced 100% by laboratory independent, point-of-care and decentralized molecular testing at the earliest, and communities are made aware about their existence and demand for them."

The science- and evidence-backed call to governments globally, to replace microscopy with the upfront rapid molecular test for TB (because microscopy underperforms in diagnosing TB and thereby misses TB cases) has been there for several years – but shockingly, action has been sketchy. This call to replace microscopy with upfront molecular tests is also among the key actions enshrined in the WHO Director General's flagship initiative to Find. Treat.All (first launched in 2018) One of the promises that were made by world leaders at the recently concluded UN High-Level Meeting on TB in September 2023 also re-echoed this call for 100% upfront molecular testing for TB.

But action is dismal. The latest WHO Global TB Report 2023 released earlier this month shows that more than half of notified cases of active TB disease did not receive a molecular test but got a microscopy test which misses TB (globally only 47% of notified people with TB received a molecular test diagnosis in 2022).

Early and accurate diagnosis breaks the chain of TB transmission

Presenting the Global Call to "Find All TB to Stop TB" in an official press meet of the World Conference on Lung Health in Paris (www. bit.ly/findalltb), Dr Tara Singh Bam (The Union's Asia Pacific Regional Director) shared that this call has received over 250 endorsements from over 30 countries worldwide in less than two weeks since its launch in Goa, India



"Early and accurate TB diagnosis is not only a critical gateway to TB care pathway but also a public health and human rights imperative. It helps stop the spread of TB infection as well as reduces unnecessary human suffering and risk of to do this, we will keep missing TB cases despite having the best of tools in the labs. Additionally, we must ensure that the full cascade of TB care services is people centred.

We must protect not only the rights and responsibilities of people with TB but also those without TB as they may be at risk of TB.

Agrees Dr Guy Marks, President of The Union. "We have focussed almost entirely on people who have TB and their immediate contacts but in fact we have not focussed enough on the rest of the community who do not have TB, and who do not want to get TB. We need to focus on the rights of people to protect themselves from getting TB in high-burden settings.

In a high TB burden setting, everyone is exposed to the TB bacteria. "That is why we have to screen everyone for TB, find all TB, treat all TB," said Dr Marks.

Over 70 years ago when there was no TB treatment, people with TB were housed in sanitoria to prevent further infection transmission. But now with effective TB treatments. people with TB disease become noninfectious soon after being put on treatment.


"In high TB burden settings, many people with TB may not have symptoms. It is important to screen everyone with WHO-recommended tools and offer them WHO-recommended molecular test upfront and

get them onto treatment quickly. What is the right TB target?

"The right TB target should not be the number of people we find with TB, but those we do not find," said Dr Guy Marks. We have to stop missing all TB cases if we are to end TB.

End the deadly divide between Global Goals and Local Realities

We have to end the deadly divide between global goals and local realities first if we are to progress toward sustainable development.

Covid vax didn't raise risk of unexplained sudden deaths in young Indians: ICMR study

NEW DELHI: Covid-19 vaccination did not increase the risk of unexplained sudden deaths among young adults in India, concluded comprehensive study by the Indian Council of Medical Research (ICMR) on Tues-

The research, published in the Indian Journal of Medical Research, showed that lifestyle factors such as current smoking status, alcohol use frequency, recent binge drinking, recreational drug/substance use and vigorous-intensity activity were associated with unexplained sudden death.

As compared to never users, the more the frequency of alcohol use, the higher was the odds for unexplained sudden death.

The research body undertook a multicentric matched case-control study in view of anecdotal reports of sudden unexplained deaths in India's apparently healthy young adults, linking to Covid-19 infection or vaccination.

The researchers determined the factors associated with such deaths in individuals aged 18-45 years from 47 tertiary care hospitals across India.

At least 729 cases and 2.916 controls were included in the analysis.

The cases were appar-

ently healthy individuals without any known comorbidity, who suddenly (before 24 h of hospitali-

sation or seen apparently healthy 24 h before death) died of unexplained causes between October 1, 2021 and March 31, 2023. "Covid-19 vaccination did not increase the risk of unexplained sudden

death among young adults in India," revealed the researchers. Instead "past Covid-19 hospitalisation, family history of sudden death and certain lifestyle behaviours increased the likelihood of unexplained

in the paper. The study also showed that taking at least one dose of COVID-19 vaccine lowered the odds of unexplained sudden death.

sudden death", they added

Patients with unexplained sudden death were four times more likely to have been hospitalised for Covid

"Our findings did not indicate any evidence of a positive association of unexplained sudden death with Covid-19 vaccination. However, a history of sudden death in the family, Covid-19 hospitalisation and certain high-risk behavioural factors were positively associated with unexplained sudden death among young Indians," the researchers said.

Gurugram: Over Rs 19 L challans issued for PUC certificate violation in Oct



GURUGRAM: Gurugram Traffic Police has issued over Rs 19 lakh challans for not having a valid Pollution Under Control Certificate (PUCC) in October, an officer said on Tuesday.

According to data shared by the police, as many as 194 vehicles were challenged in the previous month. The violators were not able to produce a PUC certificate.

'The GRAP-4 has been scaled down to stage 3 but it also restricts the plying of particular vehicles. We issued 194 challans in the previous month for not having a pollution certificate. Warnings have been issued along with fines. Those not deterred now will face appropriate action," said DCP (Traffic) Virender Vii.

Gyanvapi case: Objection filed against lawyer's plea

VARANASI: Plaintiff Shailendra Kumar Pathak Vyas has filed an objection in the Varanasi district court against an application filed by advocate Vijay Shankar Rastogi on November 8, urging it to make him a party in the civil suit that seeks appointment of a district magistrate, or any other suitable person, as the receiver of a cellar on

the southern side of the Gyanvapi mosque. The court will hear the case on Tuesday.

Subhash Nandan Chaturvedi, counsel for the plaintiff, said: "An objection has been filed in the Varanasi district court against the application filed by advocate Vijay Shankar Rastogi for becoming a party in the civil suit. Chaturvedi said he

prayed to the court to reject the application.

On September 25 this year, the suit was filed by Vyas in the court of civil judge (senior division), Varanasi.

Simultaneously, the plaintiff filed an application in the district court the same day, urging the court to transfer the suit to itself.

Advocates Vishnu Shankar Jain, Subhash Nandan Chaturvedi and Sudhir Tripathi had filed the suit on behalf of Vyas and the application for transferring it to the district court.

The suit is titled Shailendra Kumar Pathak Vyas vs Anjuman Intezamia Masajid Committee, which manages the Gyanvapi mosque.

Last month, district court ordered for transfer of the suit to itself after an application was filed in the court by the plaintiff seeking the transfer of the suit.

Covid vax didn't raise risk of unexplained sudden deaths: ICMR study

NEW DELHI: Covid-19 vaccination did not increase the risk of unexplained sudden deaths among young adults in India, concluded comprehensive study by the Indian Council of Medical Research (ICMR) on Tuesday.

The research, published in the Indian Journal of Medical Research, showed that lifestyle factors such as current smoking status, alcohol use frequency, recent binge drinking, rec reational drug/substance use and vigorous-intensity activity were associated with unexplained sudden death.

As compared to never users, the more the frequency of alcohol use, the higher was the odds for unexplained sudden death.

The research body undertook a multicentric matched case-control study in view of anecdotal reports of sudden unex-



plained deaths in India's apparently healthy young adults, linking to Covid-19 infection or vaccination.

The researchers determined the factors associated with such deaths in individuals aged 18-45 years from 47 tertiary care hospitals across India.

At least 729 cases and 2,916 controls were included in the analysis.

The cases were apparently healthy individuals without any known comorbidity, who suddenly unexplained sudden death", they added in the paper.

The study also showed that taking at least one dose of Covid-19 vaccine lowered the oddsfor unexplained sudden death.

plained sudden death were four times more likely to have had been hospitalised for Covid.

"Our findings did not

indicate any evidence of positive association of unexplained sudden death with Covid-19 vaccination. However, a history of sudden death in the family. Covid-19 hospitalisation and certain high risk behavioural factors were positively associated with unexplained sudden death among young Indians," the researchers said.

"On the contrary, the present study documents that Covid-19 vaccination indeed reduced the risk of unexplained sudden death in this age group.'
