**Cold Conditions Remain Unabated** In Kashmir




SRINAGAR: Severe cold conditions continued in Jammu and Kashmir as night temperature settled at minus 2.4°C in Srinagar on Friday.

# The Importance Of Positive Discipline

ecently our education department held a brief training session on Positive Discipline. The main aim of this initiative is to end the curse of corporal punishment completely in our schools and replace it with a more efficient and effective technique. Many of our lecturers, masters, and teachers were (wittingly or unwittingly) already aware of this technique and were practicing this nonviolent and fruitful technique wholeheartedly. n However, some of us might not be aware of the definition and the features of positive discipline.

Positive Discipline is a program designed to teach young people or learners to become responsible, respectful, and resourceful members of their communities. Positive discipline is a more effective way to manage misbehaving students in the classroom, rather than using punishment or rewards. It allows students to learn and adapt their behaviors to meet expectations in the classroom, while simultaneously teaching them how to make better choices in their path to adulthood.

Many of our teachers have already given up the habit of corporal punishment which they had learnt from their elders influenced by the traditional methods of teaching. Although, some teachers even nowadays think that corporal punishment must be an integral part of a successful education system due government's ban on it they hardly dare to practice it anymore now. Nowadays we don't see any sticks or other punishment tools in our schools which

have been a norm while we were learning in the schools in the recent past.

any teachers are bewildered about the dearth of discipline among the students and they are unable to understand how they can make their students behave properly in the classrooms in the absence of any kind of corporal punishment. The contemporary education system does not allow even a teacher to scold a student violently in the school. Some teachers even feel such a system is more derogatory for themselves. But that is mainly due to the lack of proper training of these teachers. Those teachers who are not aware of the great features of positive discipline or lack their belief in these features still hope to bring back that outmoded system which was only devastating for the learners physically, mentally as well as emotionally.

Positive discipline is a brilliant strategy. It believes in the following features mainly for a perfect classroom situation. It gives importance to Mutual respect in classrooms. Both the teacher

and the learner must respect each other for ideal learning to prevail. Positive discipline teaches the teachers particularly the main skill of identifying the belief behind the behavior. The teacher has to take each learner as a proper case study a ponder deeply to decipher the complex behavioral pattern of any learner. Positive discipline also gives importance to effective communication and problemsolving skills properly and skillfully. Proper communication between the teacher and the learner can solve all the learning issues properly.

Positive Discipline is the discipline that teaches focusing on solutions instead of punishment. It is neither permissive nor punitive. It is rather progressive in its approach. Positive discipline believes in Encouragement instead of praise. Praise can be a sheer flattering often which may lead to dangerous consequences in the long run. Encouraging a learner keeps him or her on the right track. Positive Discipline is not aimed at creating better classroom

and school environments only. It is an approach that may help us in better parenting. We have to practice it everywhere to get the better results. When we learn it wholeheartedly we understand our mistakes while nurturing the tender minds of our children and learn how to take care of them in a proper manner.

In a nutshell, we have every right to believe that if all the basic features of positive discipline are applied prop erly in our homes and schools we shall be able to bring revolutionary results beneficial for the whole society and the nation for sure. The main thing is that the parents and the teachers must believe that this technique is going to help everyone in the long run. We must learn to change our rigid attitudes and embrace the changes wholeheartedly which are necessary to bring revolutionary results in our education system particularly.

ne of the most remarkable aspects of the challenge of climate change is that often what is in any case needed in the interests of justice and sustainability is also compatible with and helpful for climate change mitigation and adaptation. If this does not appear to be so in a lot of the climate change discourse we encounter is because the big business interests have in many ways hijacked the discourse along the lines suitable for them, resulting in several serious distortions.

All this is most clearly evident in the food and agriculture sector. Agro-ecology is most suitable for protecting soil and the environment, it also provides the most sustainable livelihoods. Agroecology cannot be practiced under the highly mechanized monocultures of big business. The kind of caring and creative cultivation that agroecology needs is best provided by small farmers and family farmers, with a very special contribution by women farmers. Agro-ecology is best practiced on a land-owning pattern based on equal distribution of land among small farmer units, who work in cooperation with each other for common good. As is selfevident and is agreed by almost everyone, it is such a system of agroecology practiced by small

farmers which is most likely to produce healthy and safe food, and which is also likely to provide the best food security to the rural community and its various members.

As has been increasingly shown by a number of studies, in terms of yield per acre the agro-ecology system is capable of equaling and sometimes even surpassing the industrial farming system, all the more so if sustainability and longerterm aspects are also considered. The ability of the family farm system to minimize waste is also well-established.

At the same time, this is the system most likely to achieve very good results of climate change mitigation as well as adaptation. This system minimizes the use of fossil fuels in the form of chemical fertilizers. pesticides, herbicides, diesel, and big, heavy machines. With its emphasis on integrating

trees with crops and on various soil conservation practices, this system enables a lot of absorbing of carbon. With its strength of food security and land rights of all or almost all people, this system is capable of increasing the resilience of communities in meeting more frequent adverse weather events. Its adaptation is also enhanced by the greater cooperation for a more common good which is maximized under conditions of equality, in turn based on almost all rural households owning small plots of farmland, which can be adequately cared for and protected by those who own them and care for them. Adaptation is also enhanced by the fact that small farmers practicing agro-ecology do not have to spend a lot of cash on outside inputs or industrial inputs, and are by and large self-reliant in terms of their input needs.

Hence the chances of their indebtedness and ruin related to big expenses incurred even in bad weather years are minimized. They are self-reliant in terms of their seeds and skills; hence they can quickly adapt to weather conditions suddenly turning adverse and do not have to keep waiting for any advice from the top. Their highly decentralized system based on local skills and understanding of local conditions is great for climate change adaptation, just as it is great for climate change mitigation. Hence the compatibility and

mutually supportive nature of all the requirements of a desirable food and farming system (healthy and safe food, adequate yield, satisfactory and sustainable livelihoods, climate change mitigation and adaptation) are well-established under a small farmer agroecology system. This should be

widely appreciated and understood for farm and food policy.

However as big business is unable to extract its big profits and is unable to secure its dominance and control under such a system, it is opposed to such a system. It loses no opportunity to advance all sorts of highly suspect and even dangerous arguments to instead promote its own big business model as desirable or even essential for achieving food security as well as for meeting the challenge of climate change. These distortions spread by big business interests should not confuse and mislead food and farm policy, pushing it in entirely wrong and harmful directions.(Courtesy: Counter Currents)

# Enabling A Safer Digital Space For Women


n today's world, many human interactions are taking place in online spaces. As the internet and mobile technologies, as well as social media spaces, become more and more accessible, this is where many of our real-life activities take place. Many of us find virtual spaces safe and convenient to share opinions, exchange ideas, increase our knowledge, and find entertainment, without even stepping out of our homes.

Alas! Patriarchy is spreading its tentacles in this area too, and with every passing day, these spaces are getting more and more dangerous and unsafe for many- especially for women and girls and other marginalized communities

From posting abusive and obscene messages and /or pornographic videos and sexually explicit photos of females with the intent of blackmail, to unauthorized use and manipulation of personal information, including fake images and videos, issuing life threats and trolling, stalking women who do not toe the line or dare to question the patriarchal subjugation of women, technology-driven online violence against women and girls has taken myriad forms.

Online violence can be defined as "any act of gender-based violence against women that is committed, assisted or aggravated in part or fully by the use of ICT, such as mobile phones and smartphones, the internet, social media platforms or email, against a woman because she is a woman, or affects women disproportionately."



feminism in the virtual space', reveals that various men's groups are launching online attacks against feminism and women's rights activists on social media platforms. The study specifically captured anti-feminist and anti-gender equality content on Facebook, Twitter, and YouTube platforms that are used to oppose gender equality and women's rights in India, Bangladesh, and the Philippines.

False narratives of the online **manosphere** The analysis found that these groups of men, commonly called the online "manosphere", use a range of narratives and tactics that attack feminism and promote men's issues, and belittle women's rights activists. The narratives spread by them portray men as victims of gender equality and justify misogyny under the pretext of religion, culture, and

riage, family, and motherhood.

**Examples from India** India is one of the world's biggest internet-enabled nations, that is estimated to have an active internet user base of 900 million by 2025. 519 million Indians currently use social media. The country also boasts of the highest number of FaceBook users globally at 280 million users. There has been an increased interest in topics such as "feminazi", and "why men are better than women". Their content often uses slang in local languages, terms such as "fake feminists", viral celebrity names, and hashtags to

This narrative not only wrongly portrays women as false victims who use melodramatic pleas to gain sympathy, but also discredits and belittles the judicial process

In Bangladesh and the Philippines, too activists in the manosphere are growing in number. Topics such as "men's rights activists", "women belong to the kitchen", and "feminism destroys society" are becoming increasingly common and women

One must not forget that online public sphere is as real and impactful as its offline counterpart and the impact of online gender based violence (OGBV) is increasingly spilling over into offline spaces, sometimes with severe consequences. Correlations between in-person abuse and OGBV have been documented through multiple studies. In a recent global survey by UNESCO

celebrities and journalists are denigrated. These posts are mired in misogyny, sexism, and hatred towards women.

### The way forward

Despite the rise in OGBV, and its devastating effects it is often trivialized due to authorities taking poor punitive action-more so as there are no visible scars of the intense mental and emotional trauma associated with OGBV,



on online violence against women journalists 73% of the participants said they had experienced online violence and 20% said they had been attacked offline in connection with online violence targeting them. The top perpetrators included anonymous people (57%), government officials (14%), and colleagues (14%), and political parties (10%).

Dominant narratives used by manosphere groups in these countries justify patriarchy violence and hostility against women. They propagate victim blaming, jokes about rape, justification of attacks against feminists, and rally behind political leaders who approve of sexism and violence. They share excerpts of religious texts and sermons from religious leaders to show how gender equality has led women astray and tarnished traditional institutions such as mar-

religious beliefs and ideals. A Facebook page by the Save Indian Family Foundation aims to fight gender-friendly laws. For example, one shared meme discredits women who try to access their rights through the law. Catchphrases of the meme ask women the following two questions: Do you earn more money than your husband? Do you hide this fact in court? The meme concludes with this message to men: "We should learn how to do melodrama in court from them."

that go unnoticed, leaving indelible marks on the women's psyche. In the UNSECO study, 26% of the participating women journalists identified severe mental health impacts, while 4% had quit their jobs as a result of online violence. And this is just the tip of the iceberg of this gigantic problem.

There is an urgent need to understand this online opposition to gender equality and to develop strategies to prevent the violence it produces. One recent Indian study points out that 'the existing ally and nationally to make online spaces safer for women, including through criminalizing online misogyny and violence; Training and equipping police and law enforcement agencies to handle complaints about online harassment effectively; Making response services survivor-centred.

Private sector companies and online platforms need to identify, prevent, and remove online threats, harmful content, and abuse directed at women and other marginalized genders.

This year, the United Nations marks 16 Days of Activism against Gender-Based Violence Campaign under the theme 'UNITE! Invest To Prevent Vio-lence against Women & Girls. By using #NoExcuse as a slogan and hashtag, the campaign calls for financing different prevention strategies and transforming social norms to end violence against women and girls.

Aligned with this global campaign, UN Women Türkiye's #NoExcuse campaign underlines the importance of protective legal frameworks and calls for the effective implementation of laws to prevent all forms of violence against women, including online gender-based violence.

Masroor's recent posting was as the Station House Officer (SHO) at Chanapora, where he was posted for a few days. Lastly, he was posted at the Police Control Room (PCR), Batamaloo.

"Masroor was a gentle and down-toearth man. Despite being a police officer, he had zero craze. We were like brothers and he used to share everything with me. his friend Iqbal (name changed) said.

'I fail to understand why anybody would kill such a noble soul. The thought of his wife becoming a widow and his unborn child an orphan sends shivers down our spines. We are unable to come to terms with this tragic loss. We deeply miss him. May Allah grant him Jannat-ul-Firdous, said Iqbal, who was inconsolable and continued sobbing. Meanwhile, hundreds of people including senior police officers and officers from the administration attended the funeral of the slain inspector at Eidgah amid tears and sobs. A pall of gloom had descended in the entire area with women wailing and mourning the death of Inspector Wani-(KNO)

But mistakes happen at some times and in this case also, a mistake happened and we lost an officer," he said, adding that a "fool-proof mechanism has been put in place to avoid Eidgah-like incidents.

which includes 100 GW from solar, 60 GW from wind, 10 GW from bio-power, and 5 GW from small hydro-power.

This year, the Centre has also focused on establishing infrastructure for utilizing renewable energy sources in Jammu and Kashmir.

In the budget released earlier this year, the Centre proposed installing 4,000 additional agricultural solar pumps and commissioning about 80 megawatts of solar capacity, which would cover 20,000 families in the union territory.

Meanwhile, the Jammu and Kashmir government is also planning to harness 500 Megawatts of solar energy by 2030 under a clean energy mission.

As per the vision document of the Jammu and Kashmir government, the government has to complete the target of generating 1500 MW of solar energy in the union territory by 2047.

An official of the Jammu and Kashmir Energy Development Agency said they have been promoting the use of solar energy driven appliances.

"We are offering financial assistance for solar water heaters, cookers, and other everyday goods. A significant effort to encourage people to utilize appliances powered by renewable energy would be launched in the upcoming months," he said—(KNO)

# **Three Ram Lalla idols to** be ready for selection in **mid-December**

AYODHYA: All three idols of Ram Lalla (child form of Lord Ram) will be ready for final selection by a five-member committee of prominent seers of the 'Ramanandi' Sampradaya (sect) in mid-December.

Three renowned sculptors are busy giving final touches to the idols in Avodhva at separate locations, behind closed doors which are out of bounds for common people.

Shri Ram Janmabhoomi Tirath Kshetra Trust has constituted the panel that will select one of the three idols that will be enthroned at the Ram temple's sanctum-sanctorum next month.

It is most likely that the three idols will be ready between December 15 and 20 to go through the selection process.

Kameshwar Chaupal, a member of the Trust, said, "Ram Lalla's idol that is aesthetically closer to the deity will be selected. The 51-inch idol must resemble the five-year-old Ram Lalla.

Mahant Kamal Nayan Das, who is part of the panel that will select the idol, said, "The idol must be a replica of five-year-old Ram Lalla. Selecting one idol out of the three will not be easy. The only criterion will be its resemblance to Ram Lalla.'

Twoother members of the committee

are Mithilesh Nandani Sharanji and Jagadguru Ramanandacharya. All three idols of Ram Lalla will be based on the sketch of renowned Mumbaibased artist Vasudeo Kamath.

He had presented pencil-made sketches of Ram Lalla to Shri Ram Janmabhoomi Teerth Kshetra Trust Born in Karkala, a

Arun Yogiraj has also sculpted the 28-ft-tall black granite statue of Netaji Subhas Chandra Bose that is placed at India Gate.

# Stop fighting, let's focus on climate justice, children plead to COP28 dignitaries

DUBAI: Children are the most impacted by the climate emergency and they represent one third of the world's population (around 2.2 billion people), with half of them (more than one billion) currently living in places exposed to severe climate risks, especially in the Global South.

Children tell how the climate emergency has affected their lives. They are being seen and heard at the most influential spaces at the ongoing UN Climate Change Conference (COP28), which has entered the final and crucial phase to set the pace for a new era in climate action.

Now roughly the 196 parties to the UN climate agreement have to sort out that the fossil fuels need to be rapidly cut and poor and vulnerable nations are being hammered.

COP28 meetings will have a different participation: in addition to traditionally suited representatives of countries, 25 children's testimonies from 12 countries will be heard this week. They talk about how their lives have been impacted by the climate emergency and demand effective action from

authorities. The films were produced by UNICEF and Alana, in partnership with Bernard van Leer Foundation.

In the world today, more than one in four deaths of children under five years of age are attributable to unhealthy environments. Despite this, the children do not participate or



are taken into consideration in COP (conference of parties) agendas and negotiations, which will define their lives.

In more than 30 years since the UNFCCC (United Nations Framework Convention on Climate Change) entry into force, there has never been a decision focused on the protection of children and adolescents.

"When we speak about climate change, we are speaking about children. We need to protect their futures -- it's that simple. The powerful testimonials of children like these need to be the last thing that negotiators hear before entering discussions that determine what kind of world they will grow up in. We can only hope they listen," an official statement quoting UNICEF global lead on climate

han said

"Children are not just victims, but also active contributors as agents of change. We have seen children stand up around the world and push for solutions. They have the right to participate in decisions,' said J.P. Amaral, Nature Manager at Alana.

In the films, children from Madagascar, Somalia, Serbia, Australia, Pakistan, Kazakhstan, Malaysia, the US. Barbados. Egypt, the United Arab Emirates and Brazil spontaneously express their genuine concerns and call for immediate solutions from the planet's top leaders.

The statements arose from the question "Do you think adults are doing enough to help solve the problems of climate change? The children were defin-

itive in their responses: "I change Gautam Narasimwould like to say yes, but

they are not," says Yehan sa from Australia: "I don't think adults do anything about climate change, savs Hidava from Somalia:

"Stop fighting and let's focus on what really matters," says Sadie of the US; and "If you keep burning, we are going to die in this heat," says Raoni from Brazil, the host to COP30 in the Amazonian city of Belem do Para in 2025.

Tzeporah Berman, chairwoman of the Fossil Fuel Non-Proliferation Treaty Initiative, said: "The COP presidency has brought baggage to this process, and far too many oil lobbyists.

"For many, the presence of fossil fuel lobbyists at COP is a sign of an event that has been purchased by the opposition, and ultimately compromised.

"However, is there more here that we're missing? We think so."
