Azad, the former chief minister of Jammu and Kashmir, will contest the Lok Sabha polls from Anantnag-Rajouri constituency, the Democratic Progressive Azad Party (DPAP) announced on Tuesday

Azad left the Congress in 2022, ending his fivedecade-long association with the party, and floated the DPAP

"There are speculations that statehood will be restored in Jammu and Kashmir but on the pattern of Delhi and Puducherry where the LG has to

"This is not acceptable to Ghulam Nabi Azad. Perhaps, it will not be acceptable to any Hindu, Muslim, Sikh, Gujjar or Pahari of Jammu and Kashmir,' Azad told reporters here.

Azad said that while he had several reasons for contesting the Lok Sabha elections, safeguarding the jobs and land of the people of Jammu and Kashmir was his top priority.

"For that to happen, we need full statehood as the Assembly can then pass laws which will reserve the jobs only for the people of the state while the outsiders cannot buy land here,"

The DPAP leader said after the abrogation of Article 370, he fought for ne month.

"The result was that Prime Minister Narendra Modi and Home Minister Amit Shah agreed to restore the statehood. I think this fight has not been taken to the logical conclusion." he added.

Responding to National Conference leader Omar Abdullah expressing surprise at Azad's choice of constituency to contest the polls, the veteran politician said, "This is my state. It would be wrong for anyone to say that you are an outsider... We are all Indians."

"I contested my first election from Maharashtra, second and third elections also from Maharashtra... Omar was probably in school at that time. "Here (J&K) we are talk-

ing about adjoining districts. I am not coming in anybody's way. I have a political vision, I have a political cause to fight for. If anyone has difficulty due to that, what can I do?" he said.

On accusations that he can join hands with any party, including the BJP, Azad said, "Those who want to become slaves (of people) who look for refuge. I am the Ghulam of Nabi (Prophet) and do not need to go with anyone."

Farooq Abdullah won't contest LS polls due to health reasons: Omar Abdullah

Govt set to rationalise, streamline payment procedures for Infa projects

SRINAGAR: In a bid to expedite infrastructure development, the government is all set to rationalise and streamline the payment procedures for infrastructure projects in FY 2024-25.

A circular issued by the Finance Department regarding the rationalisation and streamlining of the payment procedures which would also help in improving the financial management and eradicating the huge outstanding liabilities of the last fiscal.

The decision is in line with the government's commitment to improve the capital expenditure so that funds be spent under the centrally sponsored schemes may be improved which will ensure efficient utilisation of all the resources.

There was a massive increase in the capital expenditure in key sectors like Road Connectivity, Power Development, Tourism, Industry, Education, Health, Water Supply etc, during the last fiscal ending March 31, 2024, to ensure rapid infrastructure upgradation of the UT.

The Government has

been also able to control the non-priority revenue expenditure with significant jump in the tax revenue and improvement in the central support.

According to the provisional data, the capital expenditure has increased from Rs. 14.666 crore in the financial year 2022-23 to Rs. 22,400 crore in the financial year 2023-24. The fiscal projection estimates a Rs. 15,000 installation for the year 2023-24, suggesting an almost 50 percent rise in infrastructure investment.

Meanwhile, the government has been able to generate more than Rs 10,300 crore from the schemes, implying a fiscal receipt for the year 2023-24.

The administration has admitted the requirement of keeping in place structured expenditure norms to avoid any unjustified rush and for the purpose of managing the public fund

Meanwhile, to remove the bureaucratic bottleneck in settlement of outstanding liabilities of the last fiscal year related with infrastructure development works, the guidelines have been issued by the UT to process mobile and other prior pending claims quickly—(KNO)

Rana slams Congress for playing 'murky games' in J&K since 1947

Marital Discords

here is an upward trend in the number of marital discords being witnessed in Kashmir valley. Horrifying details of infidelity, maltreatment and ghosting do the rounds in the social circles of Kashmir. Strangely enough, marital discord are more common in educated families than in uneducated families. Education should equip people with the knowledge to understand each other, to understand marriage in itself and to understand the rights and responsibilities of your life partner.

Lawyers are kept busy with divorce cases. Alimony, custody - these words were unheard of in Kashmiri society. But now these words are being discussed more frequently. Trouble brews up right from the first day of the marriage. Mother and the sister of the groom feel the bride now has complete control of the house and this feeling creates incurable jealousy which repeatedly manifests into abusing, shouting, quarreling and brawling. Usually, it is the female folk which instigates the husband against his wife and the other way round.

Materialism has added a new spice to the whole thing. If both the husband and wife are earning independently with a steady pay there is least likelihood that there would be subordination or obedience of any type. That is one reason why the divorce cases of female doctors, teachers, professors, advocates is on the higher side. When either partner feels that they are financially independent they do not feel the need to be subordinate to the other partner. This affects the delicate balance that entails the husband-wife relationship.

The disputes which were resolved by the elders of both families amicably are now resolved in courts. Heavy fee paid to lawyers and almost every case ends in divorce. Divorces are so common nowadays and it was not the case a few decades ago.

Both men and women, it seems, now like their jobs more than their life partners. Values have undergone a massive change. Before setting out to marry both husband and wife must undergo proper counseling about their respective rights and responsibilities. Let us hope for fewer divorces.

Carbon Capture, Too Little Too Late?

ill carbon capture technology bail society out of the latest version of greenhouse gas emissions, CO2 suddenly doubling its rate of increase when compared to the past decade, in breathtaking fashion, thus overheating the ocean and the Arctic and Antarctica and hammering Greenland?

The relationship between greenhouse gas emissions and carbon capture technology is best seen as a metaphor of athletes in the Olympic games: Team Emissions is setting world records in the 100meter dash; Team Carbon Capture is still training for the 10,000-meter marathon.

Direct Air Capture (DAC) and Carbon Capture and Storage (CCS) fall far short of meeting timelines as global emissions are outrunning all timelines, increasing two-fold within only one year, see: CO2 Bursting into the Atmosphere (3-22-2024). CO2 is on a rampage like never before and heating things up, Brazil's heat index hit 144°F recently.

According to MIT, to stay "even-with-the-board on CO2 annually," nearly 20 billion tons needs to be captured each year. It's overwhelming. Meanwhile, Earth soaks up half of the 37 billion metric tons of CO2 emissions per annum. With all of that, it still leaves too much CO2 already in the atmosphere to take the heat off global warming.

Since 1850, approximately 1,000 gigatons of human-generated CO2 is hanging out in the atmosphere, which is 1,000 billion metric tons out of a total of 2.400 billion metric tons emitted (the planet absorbing more than one-half). A large amount needs to be removed to lower atmospheric CO2 ideally to at least 350 ppm from 426 ppm. All-in, CO2 removal is a multi-billion-ton job. It's generational work kinda like building Notre Dame Cathedral, started in 1163, finished in 1345.

Total CO2 captured by current Direct Air Capture (DAC): "To date, 130 DAC plants are under development worldwide, with 27 commissioned and 18 completed (according to the International Energy Agency.) All of these are small-scale facilities with a current collective CO2 removal capacity of about 11,000 metric tons annually" (Source: U.S. Unveils Plans for Large Facilities to Capture Carbon Directly from Air, Science, August 11, 2023).

"Every second about 1,079 metric tons of CO2 are released worldwide due to burning fossil fuels." (NASA) Meaning, current capacity removes 11 seconds worth per year.

The IRA Biden plan aims to create four DAC hubs over the next 10 years, each capable of removing and storing at least 1 million tons of CO2 each year. As part of the program's rollout, DOE officials also announced funding for an additional 19 conceptual and engineering studies of potential future DAC plants. (Source: U.S. Unveils Plans for Large Facilities to Capture Carbon Directly from Air, Science,



August 11, 2023).

In strong opposition to DAC, Mark Jacobson, Professor of Civil and Environmental Engineering, Stanford University says DAC is a waste of funds. His book "100% Clean, Renewable Energy and Storage for Everything describes a 100% renewable energy economy. Nevertheless, there's still a problem of too much CO2 already in the atmosphere, which is already upending the climate system; 100% renewables will not remove it. There are no easy answers.

Meanwhile, the oil and gas industry claims it can continue to produce as much oil and gas as it wants to because Carbon Capture and Sequester -CCS- will effective ly neutralize CO2 emissions. No, it will not.

According to the Institute for Energy Economics and Financial Analysis: "Even if realized at its full potential, CCS will only account for about 2.4% of the world's carbon mitigation by 2030, according to the Intergovernmental Panel on Climate Change (IPCC).

The real issue is not whether carbon can be captured; it can be captured; however, in the big picture, the real world, carbon emissions are hardened over centuries; carbon capture is a fledgling, mostly in a testing phase.

According to the International Energy Agency, 40 commercial facilities are already in operation applying Carbon Capture, Utilization, and Storage (CCUS). Since January 2022 developers have announced plans for 50 more operations capturing around 125 Mt CO2 per year. "Nevertheless, even at such a level, CCUS deployment would remain substantially below (about 1/3rd) the 1.2 Gt CO2 per year that is required in the Net Zero Emissions by 2050 (NZE) scenario." (Source: Carbon Capture, Utilization and Storage, IEA50)

To seriously make a big dent in atmospheric carbon dioxide or CO2, which is 76% of all greenhouse gas emissions, technology is going to have to accelerate considerably, in fact, beyond considerably.

On a hopeful note, some R&D looks promising, even though still likely falling into the too little, too late category. For example, Klaus Lackner, founding director, Center for Negative Emissions has designed a prototype Mechanical Tree, on display at the Our Future Planet exhibition at the Science Museum, London from May 2021 until September 2022. The tree is constructed of sorbent tiles which cyclically extend into the air and then retract for regeneration, passively soaking up CO2 from the air using Passive Direct Air Capture (PDAC), supposedly 1,000 times more efficient than natural trees that use photosynthesis. The captured CO2 can be sequestered in underground geological formations or sold for industrial use.

MIT on carbon removal: "... a nearly impossible task, says Charles Harvey, an MIT professor of civil and environmental engineering who has studied both natural and technological ways to take CO2 out of the atmosphere. Removing CO2 is one of the hardest and most expensive ways we could address climate change—far more difficult than simply emitting less carbon in the first place." (Source: How Much Carbon Dioxide Would We Have to Remove from The Air to Counteract Climate Change? Climate Portal, MIT October 26, 2023)

"In fact, says Harvey, the energy demands of direct air capture are so great that 'canceling out' humanity's emissions this way would take more energy than we're getting from burning fossil fuels in the first place," Ibid.

'Today's approaches can capture only a tiny fraction of what's needed: around 2 billion tons of carbon dioxide annually, according to one recent study." (Smith, S.M, et al, The State of Carbon Dioxide Removal, 1st Edition, 2023)

"To 'turn back the clock' on climate change, we would need to capture today's emissions plus this enormous backlog. To reach 350 parts per million, the level of atmospheric carbon dioxide in 1988, humans would need to remove more than 500 billion tons. To get the atmosphere back to where it was before humans began to burn fossil fuels en masse would mean catching and storing more than 900 billion tons." (MIT Climate Portal)

Based upon a reasonably comprehensive study, it appears that carbon capture technology is/will be too little too late.

Global warming is not waiting around. Nevertheless, R&D is in a fluid state, hopefully (fingers crossed) it meets the challenge (big question mark) because global warming has morphed into global heat way ahead of schedule, and climate change has become a regular on nightly national news programs, featuring (1) entire boreal forests burning like a furnace (2) floods demolishing thousands of homes in China and Pakistan, killing thousands (3) droughts impeding commercial barge traffic on Europe's famous rivers (4) as nuclear power plants (France) power-down because of low river water flow (5) and thirsty Europeans standing in line for bottled water in France and Italy in the summer of '22.

Meanwhile, March 2024 news items of interest: 7,200 miles away from Europe, similar issues: Persistent Drought is Drying Out Chile's Drinking Water, Reuters News, March 20, 2024. And on another continent, Johannesburg (pop. 5.6M) CBS News headlines March 21, 2024: South Africa Water Crisis Sees Taps Run Dry across Johannesburg.

And that's not even mentioning one of the biggest concerns of the Northern Hemisphere. Greenland's northernmost glaciers are very tipsy way too early. The icy island is on the ropes; surprisingly, it rained at Greenland's summit (10,500 feet) for the first time ever as the entire ice infrastructure goes off the charts with a summertime melt rate of 30,000,000 tons per hour or 720,000,000 tons per day. 20-25% more than previously thought, according to recent studies.

And don't even think about West Antarctica or Brazil's Amazon rainforest According to NASA: "The rainforest doesn't react like it used to. It does not have enough time between droughts to heal itself and regrow. Throughout all recorded history, this has never been witnessed." (C-Counter Currents)

The Chasm Between TB And HIV Continues

The two worst global health problems have combined forces well. But the institutions addressing them have miserably failed to put their act together," wrote Dr Tim France, a noted global health thought leader, in an op-ed article titled "The chasm between TB and HIV" which was widely published in several newspapers of high TB burden countries in Asia Pacific and Africa in 2006.

Even after 18 years since then, his words remain deeply relevant. Eamonn Murphy, Director, UNAIDS Asia Pacific and UNAIDS Eastern Europe and Central Asia, opened his keynote address in the End TB Dialogues Summit held recently, underlining the importance of bringing TB and HIV services together and strikingly called upon the dire need to 'break the silos' – a clarion call which Dr France had also unequivocally given through his op-ed of almost two decades back!

"Many of the [TB and HIV] programmes are operating in isolation and almost in conflict with each other and it is not helping the patients [co-infected with TB and HIV] we all serve. There are many missed opportunities for HIV and TB service access in Asia Pacific" said

Asia Pacific is home to 21% of those who are co-infected with TB and HIV. "One-third of HIV treatment service providers do not provide TB treatment and three-fourth of TB service providers do not provide HIV treatment. This gap has got bigger overtime, and we need to work collectively to bring this down and make the programmes connect and work together" said

"I have been to hospitals where in the compound you have a TB clinic in one part, and an HIV clinic in the other part and the staff never talk. Only a quarter of countries in the Asia Pacific region include TB preventative treatment in their national HIV policies and guidelines," added Eamonn, Over 1.9 million people living with HIV had received TB preventive treatment in 2022 globally.

"The 'one patient two clinics' bottlenecks of TB HIV care - must become obsolete. There should be a commitment to joint programming that is a fully integrated model of care where all services for both TB and HIV are provided in a single facility and by the same service providers. We need to bring the 'silos'

together," said Eamonn. Even one TB or HIV death is a death too many

"As per the latest WHO Global TB Report 2023, around 48,000 people were co-infected with HIV and TB, and 11,000 of them died of TB in India. When TB is preventable and curable then even one TB death is a death too many. No one needs to die of HIV or TB," said Professor (Dr) Dilip Mathai, President of AIDS Society of India (ASI), and former Head of Medicine Department, Christian Medical College Vellore. He gave an unequivocal call to find all TB, treat all TB, and prevent all TB

among people living with HIV. Bridge the gap between "what we know" and "what we do"

Science has gifted us tools and evidence-based approaches to ensure that no one dies either of HIV or TB, and no one gets infected with either of them - provided - we bridge the gap between 'what we do' and 'what we know works."

We have highly accurate diagnostic tests (molecular tests) to diagnose TB, latest treatments which are less toxic, shorter, and more effective, and evidence-based ways to prevent TB and stop the spread. We have proven ways to 'reach the unreached' with people-centred

and community-driven "lab on the wheels" and provide a range of TB and HIV healthcare services on people's doorsteps (or as closer to the communities as possible).

Despite knowing how to break the chain of TB transmission and reduce human suffering, over 10.6 million people suffered through the disease and 1.3 million died in 2022 globally (as per the WHO Global TB Report 2023). More than half of those diagnosed with TB in 2022, got a TB test that underperforms (microscopy) and not a molecular test upfront.

Similar paradox for HIV: we have accessible and good HIV tests, lifesaving antiretroviral therapy and science to show that if a person is virally suppressed then undetectable equals untransmittable (U equals U which means there is zero risk of transmission of HIV virus from the person to anyone else). "We can end AIDS now as Michel Sidibe was UNAIDS Executive Director back then and speaking to CNS (Citizen News Service) at the Stop TB Partnership's Partners Forum in March 2009 in Rio de Janeiro,

Despite knowing how to protect people with HIV from TB. 167000 people who were living with HIV died of TB in 2022 globally. HIV continues to be the 2nd biggest risk factor for TB worldwide (undernutrition is the largest risk factor globally). Almost a million new TB cases were attributed to HIV as a risk factor (out of 10.6 million people) in 2022 worldwide.

"TB remains the leading cause of death for people living with HIV globally. In 2021, almost one-third of AIDS-related deaths were due to TB. Yet we dare to imagine a world where we find all TB, treat all TB, and prevent all TB among people living with HIV and others in the community," said Eamonn

TB-related deaths among people living with HIV since 2010 globally. We are within reach of the 80% decline target for TB-related deaths among people living with HIV by 2025," he said.

'Perhaps our target was not as ambitious as it could have been, but we still have a long way to go to make sure we can achieve that and there are many other targets and competing demands in the current environment that are challenging us" he shared.

Progress against TB and

HIV has plateaued Progress has plateaued particularly since COVID-19 service interruptions. "Only 46% of the estimated 73,000 people living with HIV who developed TB in 2021 were able to access antiretroviral therapy. This is the same level as of 2020," shared Eamonn. Overall, TB cases in Asia and the Pacific region have not declined much between 2015 and 2022 among people with HIV.

More importantly, Eamonn

"We need a well-coordinated and persistent approach to both TB and HIV, for the delivery of comprehensive quality services," said Eamonn. "We need a response that is strongly connected to the Universal Health Coverage (UHC) agenda and the 2030 sustainable development agenda. We cannot talk about achieving these or any other SDG targets if we continue the

That is why communities at risk must be at the centre of everything we do," said Eamonn Murphy of UNAIDS.

Power Woes New

Scheme have injected substantial funds into power infrastructure enhancements. Despite these investments totaling billions of rupees, a permanent solution to the persistent power cuts has remained elusive, leaving citizens disillusioned and

The recent rollout of the Revised Distribution Area Scheme (RDSS) aims to redress the existing infrastructural deficits, with an estimated expenditure of Rs. 1600 crore earmarked to complete pending works in both urban and rural areas. While progress in urban centers nears completion, rural regions lag behind. with only 60 percent of the slated works accomplished thus far.

The power generation scenario in Jammu and Kashmir presents a paradoxical juxtaposition, with a total of 29 power plants generating 3550 MW of electricity. However, despite ample production capacity, inadequate infrastructure and transmission inefficiencies result in millions of units of electricity being squandered annually, exacerbating the

In rural areas, where power cuts are a recurrent phenomenon, the situation is dire, with loose wires and outdated infrastructure exacerbating the issue. Villagers endure prolonged outages, disrupting essential services like water supply and impeding daily activities. The installation of smart meters, while a step towards modernization, has failed to alleviate the persistent woes faced by rural residents.

As the political landscape heats up in anticipation of the forthcoming elections, political parties are poised to capitalize on the electorate's disillusionment with successive governments' failure to address the longstanding power crisis. From the AAP to the BSP, voices of dissent resonate, with promises of advocacy for a permanent solution to the power woes that have plagued the region for over two decades.

With promises of imminent completion of infrastructure upgrades under the RDSS, political leaders seek to assuage public ire and garner electoral support. However, amidst the cacophony of campaign rhetoric, the electorate remains wary, skeptical of mere promises without tangible results—(KNO)

80-yr-old award-winning Aari staple artist seeks govt attention to preserve art



An 80-year-old, Mir Abdul Majeed, who has won the state award in the year 2017, said that there is a need that the government must work to provide the market to the artist instead of providing loans.

Hailing from Kalai Andar area of Old City. Majeed has been associated with this art for the last six decades and has trained dozens of people, who have been earning their livelihood by taking forward this art.

Majeed said that it was around 1960 when he started learning this art at

Khanyar. He said, "after a few years, a Japanese lady Mis Halen, brought a staple here and we made



caps, skirts, bed covers and other items. Later, I worked at many places and a few years later I started working on my own unit and reached different markets across India through this art."

He said that one of his landscape works of the Srinagar City's Hari Parbat fort was even kept as a souvenir by former Prime Minister Late Indira

He said that this work was in good demand especially in foreign countries but its demand declined after Covid-19 pandemic.

Majeed said that the art work is being praised outside Kashmir verv well and the handmade Aari staple is in demand in foreign countries especially

"Government has been trying its best to promote handicrafts but much more needs to be done as instead of providing loans to artists, there is a need to take this art to University and Colleges to impart training to the students so that they too can earn their livelihood," Majeed said.

He said that every person retires but an art knowing person never retires and earns his livelihood even in old age.

Traders from Downtown concerned as poor roads deter customers

SRINAGAR: The trade community of Sheri-e-Khaas in downtown Srinagar has voiced their concern over the dilapidated road infrastructure, citing a significant decline of their businesses.

The aggrieved traders from Sheri-e-Khaas lamented the dismal road conditions, stating that poor roads are deterring customers from frequenting the area.

"Look at the pace of work, we are suffering. Just few days are left to Eid, and we are witnessing very low magnitude of customer footfall in this market", said a copper trader.

The President of the Sheri-e-Khaas Traders Federation, Nazir Ahmad Shah highlighted that most of the roads in downtown Srinagar are either under construction or covered in lavers of dust, dissuading shoppers from visiting.

"Just take a glance at the streets of downtown, they resemble a construction site with roads resembling surgical procedures, left gaping open and impass-

Shah further highlight-

ed that due to the ongoing works many shopkeepers have to down their shutters, citing that there is no way to walk due to the drainage and other works.

able," he said.

Expressing frustration, another shopkeeper pointed out that ongoing smart city projects have taken a toll on their livelihoods. resulting in a substantial decline in business. "We were better off without this. With Eid approaching, who would venture to shop amidst these craterlike roads? We've been enduring these dug-up streets for months now,

the shopkeeper lamented. The Sher- Khaas trade body called upon authorities to expedite efforts to restore the roads of downtown Srinagar, urging that all pending roadworks be prioritized. They stressed the need for swift action to ensure the smooth operation of businesses in the area.

Meanwhile, a top official from Srinagar Smart City told KNO that the work is in full swing and is likely to be completed within soon within next two months—(KNO)


