## DCA seals 6 Medical Shops at DH Pora

KULGAM: In a bid to achieve a satisfactory level of compliance concerning the adoption of Computerized Billing Systems (CBS) within pharmacies and ascertain the quality parameters of drugs, the Drug Control Authority (DCA) today launched intensive inspections in far flung

areas of Yarikhah, DK Marg and other areas of DH Pora of District Kulgam.

The inspections were carried out by a team of officials from Tehsil office DK Marg, Executive Magistrate (Tehsildar DHPora) besides other officials.

Strict directions were passed to the chemists of the area to install computerized billing systems in their premises for bringing transparency in sale and purchase records

On the occasion, nine drug samples were lifted to ascertain their quality parameters and six medical shops were sealed for violation of conditions of

licenses and other norms. Records of Schedule H/ H1 drugs were checked on spot and several show cause

notices were issued where the discrepancy was found. It is worthwhile to men-

tion that the Drug Administration has adopted a zero tolerance approach in misuse of any habit forming drug, and has taken many stringent measures like launching prosecutions, suspension/ cancellation of licenses to deal with such incidents.

The government must have its eye on the lodging facilities, electricity, water, communication, health, fire, and emergency services and have enough stocks as a backup.

We are hopeful that our security forces would be able to provide adequate security along the route. May this Amarnath yatra bring peace and prosperity to the valley as well as the Jammu region. We are hopeful that with Lieutenant Governor Manoj Sinha as head of the administration pilgrims willenjoy their stay in Kashmir.

# Reject The Glorification Of The Ruling Class And Their Capitalist Ideologies

n the broader social and collective conception, ideals such as human happiness, freedom, democracy, peace, equality, justice, solidarity, and prosperity have been either totally neglected or pushed aside as irrelevant in the pursuit of economic growth and development to establish and expand capitalism. Under the dominant capitalist paradigm, economic indicators like GDP growth and market expansion are prioritised over social well-being and equitable development. This focus on economic metrics overlooks the importance of comprehensive human development, which encompasses more than just economic growth.

In terms of human happiness and freedom, the ruling class often equates these with consumerism and individual liberties, overshadowing the importance of collective well-being and social jus-tice. Mass consumerism expands commodity market for profit by commodification lives, labour and society. Democracy is presented as a hallmark of free societies, yet the ruling class influences electoral processes and policy making to ensure that their interests are preserved. The deepening of democracy is delayed for the pursuit of market interests. Human happiness, for example, is often reduced to consumer satisfaction, ignoring the deeper aspects of well-being such as mental health, community bonds, and a sense of purpose. Freedom is frequently equated with purchasing power and market freedoms, overshadowing the significance of political and social liberties. Democracy, instead of being a genuine participatory process, becomes a facade where economic elites exert sig-nificant influence over political decisions.

Peace, equality, and justice are similarly compromised. In many cases, economic growth is pursued at the expense of social harmony, leading to increased inequality and social unrest. The environmental degradation that accompanies unchecked economic development further exacerbates social inequalities and threatens long-term sustainability. Solidarity and collective well-being are often undermined in a capitalist society that champions individualism and competition. The social fabric weakens as people are pitted against each other in the race for economic success, leading to a fragmented society where the vulnerable are left behind. In pursuit



of prosperity defined by material wealth, the richer segments of society accumulate more resources. while the poorer segments face growing hardships. This disparity is rationalised by the ruling class as a natural outcome of economic growth, sidelining the moral and ethical imperatives of justice and equality.

The skewed conceptions of peace, nationalism, wars, markets, human happiness, freedom, democracy, and everyday governance in contemporary discourses are shaped by the ideas of the ruling class. Everyday governance, from local municipalities to national governments, is also subject to the ruling class's influence. Through lobbying, campaign financing, and control over media, they shape public opinion and policy decisions to align with their objectives. This pervasive influence underscores the importance of critical thinking and awareness among the populace to challenge and dismantle these entrenched power structures to reclaim freedom, democracy and citizenship rights.

The ruling class continues to propagate their ideas as the only viable alternatives, presenting these ideas and projects as their own initiatives. However, they also make working people believe in these ideas and projects as if they are universally beneficial. By



gies as common sense or the natural order of things. This manipulation is strategic, ensuring that the working class internalizes these beliefs and supports policies that ultimately serve the interests of the elite. The ruling class employs various means to achieve this. including cultural narratives that glorify individualism, meritocracy, and free-market capitalism.

For example, in many societies, the concept of success is often tied to hard work and individual effort, overshadowing the structural barriers that impede equal opportunity to majority of working people in the society. This narrative convinces working people that their socio-economic status is a result of their own actions, rather than systemic inequalities. It is also important prioritise human happiness, freedom, democracy, peace, equality, justice, solidarity, and prosperity alongside economic growth to build a more equitable society and sustainable planet, where people are free to pursue their dreams and happiness.

# Timely And Accurate Diagnosis To Stop Misuse Of Medicines

rug-resistant diseasecausing microbes can infect any one of us. Bhakti Chavan, a promising biotechnologist, who never had TB before, got infected with extensively drug-resistant TB (XDR-TB) bacteria. XDR-TB is one of the most serious forms of TB. After some delay, an accurate XDR-TB diagnosis helped her access the right treatment, thanks to an MSF clinic. With steely resolve and grit, she went through the difficult treatment of XDR-TB and got cured. Not only has she defeated XDR-TB. but she also champions the cause of helping those who are fighting TB as well as drug resistance or antimicrobial resistance worldwide.

Bhakti got the WHO recommended molecular test diagnosis. But 79% of people with TB disease in India are not diagnosed on WHO recommended molecular test, but through sputum microscopy which underperforms in diagnosing TB (as per India TB Report 2024). That is why WHO has called upon all the countries to completely replace microscopy with upfront molecular tests for TB diagnosis by 2027. All world leaders re-echoed this call for 100% upfront molecular test diagnosis at the UN General Assembly High Level Meeting on TB last year.

Unless we ensure that timely and accurate diagnosis for TB and all other diseases is a reality on the ground, how will we stop misuse or overuse of medicines and prevent antimicrobial resistance?

### People-centred diagnostics, treatment and care is key

Even though they face the brunt of it, most people have very little understanding and awareness about antimicrobial resistance (AMR). Bhakti Chavan blames it on the lack of people-centred responses to address AMR.

Bhakti, who has done her post graduation in Biotechnology and currently works with a biotech company, says that, "Many countries have National Action Plans to address AMR, but the ground level realities are very different. Take for example TB. Despite India having a National Strategic Plan to end TB (2017-2025), there are many gaps in TB care-like shortage of medicines, restricted access to novel medicines, diagnostic delays due to non-accessibility of molecular tests. All these act as roadblocks for the underprivileged in accessing the best of diagnostics and treatment. Our public health programmes must ensure that the best possible care is available to all those in need, and also ensure prevention of spread of infection. So patient-centred diagnostics (including upfront drug sensitivity testing), treatment and care is most important to combat AMR.'

Bhakti is one of the 12 members of the World Health Organization (WHO) Task Force of AMR Survivors, which consists of persons who have survived drug-resistant infections or have cared for those with such infections. It was established by the WHO with the aim to humanise the narrative around AMR. Bhakti wants more such committees or task forces to be formed at national level so that more survivors can join them to create awareness and literacy around AMR and help in combat-

### **Antimicrobial resistance**

The world is abuzz with the everincreasing menace of AMR which is listed among the top 10 global health threats, and kills more people than TB, HIV or malaria combined. The year 2024 is particularly an important one for the global response to AMR, with the UN General Assembly (UNGA) High Level Meeting on AMR due to take place on 26 September 2024 in New York.

Behaviour and Allied Sciences (IHBAS) and President of Delhi Society for Promotion of Rational Use of Drugs, calls for coordinated efforts that are focused on diagnostic stewardship, antimicrobial stewardship and infection prevention and control, to deal with this manmade crisis.

But for the layperson (who is at the receiving end of this threat) what do these medicalised terms mean? What do words like 'antimicrobials' and 'antimicrobial resistance' signify?

To put it simply, antimicrobials are medicines that are used to treat and prevent infections in humans, animals and plants by killing the germs (or pathogens) - like bacteria, parasites, viruses and fungi- that cause these infections. However, the germs fight back and, over a period of time, some of them become resistant to these medicines, making them ineffective. In scientific language we call this phenomenon antimicrobial resistance tions alone were directly responsible for 1.27 million deaths in 2019. And 20% of these deaths were in children under 5 years.

Antimicrobials (that include antibiotics, antivirals, anti parasitics, antifungals) target specific pathogens. They are not directed against specific body conditions-like diabetes, hypertension, calcium deficiency, etc. Thus they are very different from analgesics, antipyretics or blood pressure control pills, and need to be handled with care, explains Dr Sharma.

### Multi-pronged approach to con-

We can control AMR by implementing the triple shield strategy comprising:

- · Timely and accurate diagnosis to avoid unnecessary use of antimicrobials (called Diagnostic
- Stewardship); Appropriate and rational use of

control measures. Correct diagnosis is the foundation

### for initiating effective treatment

Diagnostics stewardship involves the various stages of microbiological diagnosis to identify the infection causing pathogen and to do its culture and sensitivity testing to find whether it will respond to X, Y or Z antibiotic

Dr Sharma calls diagnostic stewardship the roadway to antimicrobial stewardship: "It is an important first step that helps in doing the right testing for the right patient at the right time, so that appropriate decisions can be taken for the management of the infection. Antimicrobial misuse is driven by diagnostic uncertainties. We have very good molecular and rapid diagnostic tests available for many diseases. But unless we use them at the right time for the right patient, it

Underuse and overuse fuel AMR

Dr Sharma points out that both overuse and underuse of antibiotics fuel AMR. "Underuse happens if the patients in need of antibiotics are not able to get them, either because of accessibility or availability issues, or perhaps the diagnosis was not done. So, in the absence of treatment the person [with an infectious disease] remains infectious for a longer period of time and infection spreads to more

and more people," said Dr Sharma. More emphasis needs to be put on infection prevention and control. Strong infection prevention and control is a very effective approach to control the spread of AMR. WHO recognises that "the most effective intervention is to improve hygiene in healthcare facilities, including promotion of hand hygiene. Safer hospitals mean fewer infections and every infection prevented is an antibiotic

Proper sanitation, including proper waste disposal, simple hand cleaning practices, and availability of clean drinking water can go a long way in fighting infections, both in and out of

### Antibiotics are not a 'shortcut' to circumvent infection prevention and control

Dr Sharma cautions that antibiotics should not be used as a shortcut (as they often are) to circumvent infection prevention and control activities. She also advises against the use of antibiotics in situations like treating a wound (debridement or simple cleaning would do) or dealing with a

normal vaginal delivery.
All these efforts will not only help in managing the individual patient well, they will also slow down the process of AMR and help preserve existing antimicrobials for use by the future generation.

### Will world leaders include AMR survivors at the UNHLM on AMR?

World leaders would be meeting at the upcoming 2024 United Nations General Assembly High Level Meeting on AMR. Bhakti Chavan calls upon them to include the voices and faces of AMR survivors in all deliberations at the forthcoming UNHLM on AMR, as they are the ones who suffer the worst consequences of AMR.

And as Bhakti rightly says: "AMR might be invisible, but the survivors are not.

(AMR) - meaning the microbes or the disease causing germs have become resistant to the drugs and no longer get killed or destroyed by them. So treatments become less effective (or ineffective) and infections persist, spreading to other people too.

AMR is a natural phenomenon, as the pathogens evolve over time to evade their enemy- the antimicrobials. However the process is hastened and escalated by overuse and misuse of antimicrobials in humans, animals and crops. We cannot stop this phenomenon, but we can definitely slow down the process, in the interest of

A report in The Lancet estimated that drug-resistant bacterial infec-

antimicrobials (including antibiotics), to improve treatment outcomes, reduce antimicrobial resistance, and decrease the spread of infections caused by drug-resistant organisms (called Antimicrobial Stewardship); and

Reducing spread of infections by practicing hygiene and other infection control methods (called Infection Prevention and Con-

While the onus of implementing diagnostic stewardship and antimicrobial stewardship lies largely with the healthcare facilities, the public and medical fraternity are equal partners in implementing infection may not give the right kind of results to help tailor the antimicrobial prescription.'

Antimicrobial stewardship is about preventing misuse of antimicrobials by optimising their use- that is, preventing their over use- as soon as a

correct diagnosis has been made. "This optimisation can happen in the form of switching from broad spectrum to narrow spectrum (or targeted) antibiotics, or reducing the number of antibiotics which may no longer be needed for patient management, or prescribing shorter duration antibiotics, or switching from intravenous antimicrobials to oral ones, depending upon the patient situation," said Dr Sharma.



# Centre okays Rs 700 crore to set up institutes of pharma, medical technology

NEW DELHI: The Central government has earmarked Rs 700 crore to set up centres of excellence at the National Institutes of Pharmaceutical, Education & Research (NIPER) over the next five years to boost pharma and medical technology in the country.

Of the Rs 700 crore, a sum of Rs 243 crore has been approved for 2024-25, according to a notice issued by the Department of Pharmaceuticals (DoP), under the Ministry of Chemicals and Fertilisers.

There are currently seven NIPERs spanning seven states in the country -- Mohali(Punjab), Ahmedabad (Gujarat), Hajipur (Bihar), Hyderabad (Telangana), Kolkata (West Bengal), Guwahati (Assam) and Rae Bareli

(Uttar Pradesh). These will broadly focus

on research ranging from medical device manufacturing, bulk drug R&D, phytopharmaceuticals. biological therapeutics. and antiviral and antibacterial drug discovery and

development. Former health minister Mansukh Mandaviya said that the Union Cabinet had in 2023 approved the Promotion of Research and Innovation in Pharma-MedTech sector (PRIP) scheme with an outlay of Rs 5,000 crore for five years,

from 2023-24 to 2027-28.

Again in 2023, a Parliamentary Panel recommended the government allocate more funds for new initiatives, such as the establishment of the National Institute of Medical Devices Education and Research (NIMERs) and Indian Council of Research & Development and Innovation in Pharma-MedTech Sector (ICPMR)

It was mentioned that the DoP had asked for Rs 1, 286 crore for FY24, of

which Rs 560 crore was to set up NIPERs, and the remaining amount to be used for new initiatives under the NIPER scheme, such as NIMERs (Rs 200 crore), Centres of Excellence (Rs 233 crore), ICPMR (⊠50 crore), and Promotion of Research & Innovation in Pharmaceutical Sector (Rs 243.00 crore).

Meanwhile, as per media reports, a production-linked incentive (PLI) scheme for domestic production of Glucagon-like peptide-1 (GLP-1) drugs -- used in the treatment of obesity and diabetes -- is also expected to be rolled out in India by 2026.

It is important for the Indian population, with rising incidences of diabetes and obesity. The current formulations of GLP-1 drugs by the US' Novo Nordisk (Ozempic) and Eli Lilly (Zepbound) are unavailable in India.

### Centre to conduct thorough check of airports, says Civil Aviation Minister

**NEW DELHI:** Following the canopy collapse at Terminal-1 of Delhi's Indira Gandhi International (IGI) Airport on Friday, the Centre will conduct a thorough check of all the airports in the country.

Union Civil Aviation Minister Ram Mohan Naidu Kinjarapu, who visited the Terminal-1 site soon after the incident, said, "We will conduct a thorough check on all the airports that come under our purview...we will make the necessary report and see if there is a requirement for an independent body for this."

At least one person died and four others were injured when a canopy at Terminal 1 collapsed on Friday amid heavy rain.

### Rain submerges Delhi-NCR, breaks 88-year-old record

**NEW DELHI:** Heavy rainfall in Delhi-NCR that started on Thursday, led to widespread waterlogging and severe traffic jams on

Friday morning. According to the Meteorological Department, Delhi received 228 mm of rainfall from 8:30 A.M. on Thursday to 8:30 A.M. on Friday, marking the highest 24-hour rainfall in June since 1936, when 235.5 mm of rain was recorded.

Typically, Delhi receives an average of 80.6 mm of rain in June.

The deluge significantly impacted daily life in Delhi-NCR, with commuters facing severe waterlogging and traffic jams during their morning commute. However, the downpour

provided respite from the intense heat of the past two months, with the minimum temperature on Friday recorded at 24.7 degrees Celsius, 3.2 degrees below normal.

This unprecedented rainfall has highlighted the shortcomings in the city's infrastructure.

Despite claims by Delhi Mayor Shelly Oberoi on June 18 that the city was prepared for the monsoon. the first significant rain has already caused sub-

stantial waterlogging. Shelly Oberoi had previously assured that the storm drains were clean and ready, promising a hassle-free monsoon for Delhi residents. Major intersections like ITO saw about two to three feet of water accumulation, causing extensive traffic jams.

### Jharkhand HC grants bail to ex-CM Hemant Soren

**RANCHI:** The Jharkhand High Court on Friday granted bail to former Chief Minister Hemant

Soren in the land scam case. On June 13, Justice Rongon Mukhopadhyay reserved the decision on Soren's bail plea.

Soren was arrested by the Enforcement Directorate (ED) on January 31 in connection with money laundering linked to the land scam. He was lodged at Birsa Munda Central Jail in Ranchi since then.

During the hearing, Soren's counsel, Kapil Sibal and Meenakshi Arora, argued that the land in question was "bhuinhari", under the Chotanagpur Tenancy Act, and could not be sold or

Assistant Solicitor General Raju also alleged that Soren had misused his position to influence the investigation and might try to disrupt it further if granted bail.

## Murderers of democracy claim to be its guardians: Chugh

**SRINAGAR:** In a step to bolster party unity and prepare for the upcoming Assembly polls, BJP National General Secretary and In-charge of Jammu & Kashmir. Tarun Chugh, convened a seminar at Church Lane in Srinagar today. Stressing the importance of grassroots organization for the upcoming Assembly polls, Chugh urged the workers to fortify the party's presence.

Reflecting on the 50th anniversary of the Emergency imposed in 1975, Chugh highlighted its lasting impact on Indian democracy. He noted, "It has been 50 years since the imposition of the Emergency in this country. Yet, the Congress Party still bears the burden of this sin. Why do they become so agitated and restless whenever this issue is discussed? It is essential to tell the country why the Emergency was imposed.

Chugh recounted the events leading up to the Emergency, beginning with the Allahabad High Court's invalidation of Indira Gandhi's election from Rae Bareli. Indira Gandhi's election was invalidated by the Allahabad High Court, leading



her to seek a stay from the Supreme Court, which did not grant a complete stay. This legal predicament set the stage for the imposition of the Emergency.

"Those who murdered democracy during the Emergency now hypocritically claim to be its guardians," said Chugh. "It is outrageous that the very people responsible for that dark chapter in our history now present themselves as the protectors of democratic values."

"Leaders like Lok Nayak Jayaprakash Narayan, Atal Bihari Vajpayee, Lal Krishna Advani, and many others were arrested," he recounted. "Press censorship was imposed, and the publication of Indian Express was shut down. No one could write or say anything against the gov-

Highlighting the judicial compromises during this period, Chugh pointed out the example of Justice H.R. Khanna. He said, "Justice H.R. Khanna, who stated that fundamental rights cannot be suspended even during an Emergency, was not allowed to become the Chief Justice of India. RSS volunteers in jail were tortured, leading to many deaths.'

He criticized the Congress for never apologizing for the Emergency and pointed out their discomfort during recent commemorations. "When a two-minute silence was observed in memory of those who died, the Congress was disturbed. What is the problem with discussing this dark chapter after 50 years?"

Chugh called on current leaders to remember the impact of the Emergency on their predecessors 'Akhilesh Yadav, Stalin, Kanimozhi, and Tejashwi should remember that their fathers were also in jail during the Emergency," he said. "This is Congress's true history—no faith in democracy, nor in democratic traditions."

Reassuring the party's commitment, Chugh highlighted that the BJP, under Prime Minister Narendra Modi's leadership, is dedicated to preventing such an event from happening again. "Prime Minister Shri Narendra Modi Ji and the BJP have clearly stated that there will never be an Emergency in this country again. No citizen's rights will be violated again under the rule of Dynastic poltics'

He concluded by celebrating the resilience of Indian democracy and the electorate's response in the 1977 general elections, where Indira Gandhi faced significant losses. "The strength within this country defeated the dark chapter of Emergency, and on its completion of 50 years, we proudly acknowledge this and commemorate it so that such a thing never happens again.
